OPEN PUBLIC FORUM-

Discussion held re: Powhatan Point Senior Center-Present: Pattie Meyer, Priscilla Jeffers; Melda Gallaher (Association President); Joseph Jeffers; James Thomas

Pattie Meyer voiced her concerns regarding the Powhatan Point Senior Center. "Our current center is located directly in a flood zone, so when there's a hint of a flood we have to move everything. Moving is a real hassle, and the water is affecting the integrity of the building. In addition to the flood threat, we are now having to contend with the problem of traffic from the local oil and gas industry," said Mrs. Meyer. She noted the seniors have a chance to buy another building for a cost of about \$114,000.00. Mrs. Meyer said, "We know that you're not in the business of buying buildings for senior centers, but this is really an exception. These people are struggling down there. They need your help. There is another person looking at the building, so if it goes, there's actually no other place in Powhatan, most of the town's below the 100-year flood marker." She said an oil and gas company has offered to "help a little bit." Melda Gallaher, Powhatan Point Seniors Association president, said they know the Commissioners had purchased a senior center in Flushing and helped out other centers. Mr. Dutton said he has had the opportunity to come down (to Powhatan) to talk to them and see the building. He said currently there are nine senior centers in the county which are under various arrangements. Whether the county owns the building or if the building is leased or owned by a senior association, this all happens from support of the levies passed by the residents. He said there is some reluctance for the county to purchase and take this on the long-term. He understands the situation and does feel the flooding is a concern along with the parking situation being a safety concern. Mr. Thomas said, "The County does not own this building, it is privately owned. While we understand the situation, we also have a budget. We have a fiduciary duty to 70,000 people in this county, relative to the Senior Services budget." He voiced an opinion for the future board when they look at the 2019 budget. "Is there availability through the funds that are there to do something with a new building, regardless of the fact there's potential flooding issues, which have always been there. It comes down to what's in the best interest of the tax payers of Belmont County. We can't forget that. We have been blessed over the years that these senior services levies always pass, but they're levies which are renewed mostly every five years or so, and you have to be cognizant that that money could go away as easily as it's coming in right now. Those are the factors you have to weigh," said Mr. Thomas. Mrs. Meyer asked if the ad valorem tax could be used. Mr. Thomas said by Ohio law, senior services levy money needs to be used, not general fund money. He said the general fund money is barely enough to cover daily services of the county. "There's no additional funds out there, In fact, quite frankly, the Commissioners are looking at cutting the budget again for 2019 because there's less money coming in," said Mr. Thomas. Mr. Dutton said they will continue to have conversations about the issue. Frank Papini asked if senior service levy money was used to purchase the Flushing center. Mr. Thomas said yes. Mrs. Gallaher added someone can't get a wheelchair in the restroom and she is concerned someone is going to get hurt crossing the road. Joseph Jeffers, Powhatan Senior Center, questioned if the seniors would obtain a new building would the Commissioners continue to pay the electric bill. Mr. Dutton said yes. Mr. Dutton said the board fully understands the situation and will continue to have conversations and come to a decision. He said he appreciated everyone coming today.

Jerry Echemann told the Board a woman called him about a former bank building being for sale in Colerain. She felt it could serve as a new location for the Colerain center. Mr. Dutton said, "That kind of speaks to the point. The situation in Powhatan is different, but what Commissioner Thomas mentioned, taking on those types of purchases, long-term, where does the risk become, to the County, in terms of future levy dollars and future budgets, in the long-term legacy of those buildings, when does that become a risk of becoming a potential liability to the tax payers of Belmont County if things went away?"
