SECTION III – Cooperation Statement

The LPA shall cooperate with the Director of Transportation in the above described projects as follows:

The LPA agrees to participate in all associated costs of the projects including; geotechnical engineering, preliminary design engineering, environmental analysis and reporting, right of way, if necessary, construction, and construction engineering.

The LPA and STATE agree that the STATE has set aside available Federal-aid funds for the financing these improvements from funds allocated by the Federal Highway Administration U.S. Department of Transportation for emergency highway repairs at Eighty Per Cent (80%) with the LPA participating in such remaining costs at Twenty Per Cent (20%); and

At present, the cost estimates for development, design and construction of the projects are indicated on Exhibit A attached hereto.

The LPA further agrees to pay 100% of the cost of those features requested by the LPA which are determined by the State and Federal Highway Administration to by unnecessary for the Projects.

The LPA further agrees that change orders and extra work contracts required to fulfill the construction contracts shall be processed as needed. The State shall not approve a change order or extra work contract until it first gives notice, in writing, to the LPA. The LPA shall contribute its share of the cost of these items in accordance with other sections herein.

The LPA further agrees to pay 100% of the cost to install and/or repair curb ramps at all necessary intersections to ensure compliance with the Americans with Disabilities Act.

SECTION IV – Utilities and Right-of-Way Statement

The LPA agrees to acquire and/or make available to ODOT, in accordance with current State and Federal regulations, all necessary right-of-way required for the described Projects. The LPA also understands that right-of-way includes eligible utility costs.

The LPA agrees to be responsible for all utility accommodation, relocation and reimbursement and agrees that such accommodation, relocations, and reimbursements shall comply with the current provisions of 23 CFR 645 and the ODOT Utilities Manual.

SECTION V – Maintenance

OPEN PUBLIC FORUM-John Jurovcik said a lot of people in the county are upset about the water and sewer rate increases. He said he thought a sewer plant was to be built by the mall. Mr. Dutton said he didn't know the timeline and they are working with the USDA on both water and sewer projects in terms of grants and loans. The sewer project paperwork has not yet been completed, once completed USDA will release funds. He added this was the largest package ever approved by the USDA. He said Boards of Commissioners chose not to raise the rates for a long time and we were not able to get any assistance since the rates were not where they needed to be. Mr. Dutton said when he and Commissioner Meyer joined the board they made the difficult decision to raise the rates. He noted the last sizable adjustment was at the beginning of this year and there will be continued adjustments based upon the rise in inflation. He said we have aging infrastructure that needs replaced and the system was neglected for a long time. "We can't afford to have a weak system because we're responsible to our current customers and potential future customers," said Mr. Dutton. He said if smaller entities' systems fail, they look to the county for backup. Our system was neglected for a long time but he thinks we are on the right path. Mr. Meyer said it takes a vast amount of resources (manpower, chemicals, etc.) on a daily basis to get water to residents.

John Jurovcik asked if the county received any money from gas and oil. Mr. Dutton said yes in different ways. They receive it from the sales tax and hotel and motel usage. Those dollars (hotel/motel tax) go to Belmont County Tourism Council by state law. The county has leased county property. Funds are set aside from that activity which they intend to use towards debt repayment or potential infrastructure. He said water and sewer is an enterprise fund, it's supposed to run outside of the general fund. That's not how it has been run in the past; the county has at times intermingled.

2019 Annual Appropriations

Mr. Dutton provided some background on the past year budget process and sales tax. He said this budget that they are passing does not signify all funds that are required to operate the county; it's just the General Fund that is funded mainly through sales tax that are generated. He added a large portion of the property taxes goes to the school districts and various levies and only a small amount, less than 5 cents of that dollar, goes to the county. Mr. Dutton said some departments have other sources of revenue that come into their offices. Levy funds are not reflected into the General Fund budget. Water and Sewer Department operates from monthly bills, Engineer's office has two primary sources of funding which are funds from license plate fees and a portion of the gasoline tax. He noted the General Fund is the Commissioners' primary responsibility to oversee, manage and appropriate funds. Mr. Dutton said, in general, they have seen a flattening in sales tax receipts over the last couple of years, but historically they are at a higher level than at any point in history. A significant loss of revenue in 2018 that will continue in the future was a state decision of how Medicaid was taxed. Some transitional funding was received from the state, but it won't continue. Mr. Dutton said they feel confident in Belmont County's retail. He said they continue to see companies doing well. Mr. Dutton said they are looking at a budget for 2019 of \$21,962,080.71. In 2010, 2011, 2012 and 2013 the budget was roughly \$17.5 million. In 2013 the budget was \$19.6 million, 2015 it was \$21.5 million, 2016 it was \$21.6 million and 2017 it was \$22.3 million; it has held there since 2017. Mr. Dutton said they have been taking a closer look at the budget and have been trying to evaluate what is needed to operate the different county departments and separate needs from wants. The Board is not looking for layoffs or reduction of services, but they also want to make sure they are flexible enough to pay down debt. He said the county is in a good position right now, debt wise. They also want to be flexible from an infrastructure standpoint for opportunities that may be coming down the road so they are being as cautious as they can regarding the budget. Mr. Dutton said 2019's number is less than the last few years. They get direction from the County Auditor, there was a delay this year, who said to anticipate the same or less than last year. The Board didn't have a top line number when they had to decide so they took a conservative approach. He said there may be some additional dollars needed for a few departments to make sure they have the funds to operate in 2019. Mr. Meyer thanked staff, Lisa Vannoy and Jaclynn Smolenak, and said they are tremendous in helping develop the budget. He said the Board will continue to look at the budget throughout the year. Mr. Meyer added he is confident about the budget and it efficiently meets the needs for what the county provides on a daily basis. Mr. Echemann said he had no input with the process this year and his vote will reflect that. Mr. Dutton said they have a fantastic staff in the Commissioners' office and recognized Mrs. Vannoy and Ms. Smolenak. He said they are on top of things and ready with answers. John Jurovcik asked if the county has any carryover. Mr. Dutton said yes and various departments can carry over funds. Mr. Meyer explained the carryover can help get you get started for the year. Mr. Echemann said his vote isn't due to any concerns with the budget, he just wasn't involved.
