CONTRACT BETWEEN THE BELMONT COUNTY DEPARTMENT OF JOB AND FAMILY SERVICES (BCDJFS)

AND

JEFFERSON COUNTY COMMUNITY ACTION COUNCIL, INC. (JCCAC) (CONTRACTOR)

PURPOSE:

To coordinate activities required by the WorkForce Investment Act and/or Ohio Option. Activities will be coordinated with the Belmont County Department of Jobs and Family Services in collaboration with the WDA of Belmont County, at the direction of the WorkForce Investment Board (WIB).

THE CONTRACTOR AGREES TO PROVIDE THE FOLLOWING SERVICES TO THE BCDJFS:

Coordinate the implementation and operation of the WorkForce Investment Act and/or Ohio Option.

Under the direction of the WIB, prepare, modify, as needed, and submit the Strategic Five Year Local WorkForce Development Plan and the Youth Plan for the combined two county area. Finalization of preparation and modification shall be done only after inter-group communication with both WDA's.

Provide liaison between state and federal programs monitors. Coordinate WDA's response to the monitoring reports.

II. Gather and submit information to the WDAs to use for reporting to the WIB.

On-site and desk reviews of the WDAs and subcontractors, as applicable, to ensure system integrity, validate internal controls, participant tracking systems and provide recommendations for enhanced system performance in both areas of

technological and WorkForce development activities/outcomes.

Provide written documentation of monitoring results to monitored agency, WorkForce Development Agency, and other entities as directed by the WDA.

- III. Coordinate WorkForce Investment Board (WIB), Youth Council, a subcommittee of the WIB (YC), and One-Stop meetings.
 - A. Maintain membership rosters for each group including mailing address, e-mail address, telephone numbers and fax numbers. Rosters shall be distributed to all members of each group with changes being distributed timely.
 - B. Plan and Provide meeting materials as directed by the WDA's.
 - C. Prepare a written agenda and minutes of WIB, YC and One-Stop meetings.

IN COOPERATION WITH THE WORKFORCE INVESTMENT BOARD, THE BELMONT COUNTY DEPARTMENT OF JOB AND FAMILY SERVICES (BCDJFS) AGREES TO PROVIDE THE FOLLOWING:

BCDJFS agrees to cooperate and collaborate with Jefferson County Community Action Council, Inc. (JCCAC) to plan, implement and monitor the provision of services under this agreement.

BCDJFS agrees to maintain communication with Jefferson County Community Action Council, Inc. (JCCAC), on local WorkForce Development programs and related activities.

BCDJFS will coordinate with Jefferson County Community Action Council, Inc. (JCCAC), to accomplish the following:

Monitoring and reporting WIA performance for the one-stop system and its partners and contracted vendors.

Submitting all reported information to the Local WorkForce Investment Board and ODJFS.

Maintaining the Eligible provider list for the ITA system, per the direction of the Local WorkForce Investment Board.

EFFECTIVE DATE:

The effective date of this contract shall be October 1, 2001, upon approval and signature of all parties and continue through June 30, 2002. Contract may be extended one (1) year to June 30, 2003, upon agreement of both parties.

CONSIDERATION:

- 1. Jefferson County Community Action Council, Inc. shall submit invoices on a Monthly basis. Invoices shall be submitted to the Belmont County Department of Jobs and Family Services, to the attention of the Fiscal Officer. All such invoices shall contain the following information:
 - 1. Contractor name, address and Federal ID number.
 - 2. Billing period.
 - 3. Total amount of invoice.
 - 4. Authorized signature.
- 2. Payment by BCDJFS shall be made within fourteen (14) days of receipt of correct invoice.
- 3. Payment rate is \$3,339.67 per month.

EVALUATION AND MONITORING

The BCDJFS, with the cooperation of JCCAC, will complete periodic monitoring and evaluation activities as deemed necessary by the BCDJFS. The continuation of this contract shall be contingent upon the program objectives contained in the contract being achieved.

JEFFERSON COUNTY COMMUNITY ACTION COUNCIL, INC. OBLIGATIONS

Jefferson County Community Action Council, Inc. shall abide by Federal, State and Local laws, ordinances, regulations, and/or guidelines and any additions, deletions or amendments thereto.

Jefferson County Community Action Council, Inc. shall not perform in any way inconsistent with the terms of this contract except as approved, in writing by the BCDJFS. Adjustment in the services to be provided may not be made without prior approval of the BCDJFS.

TERMINATION

Either party upon thirty (30) days written notice may terminate this contract for any reason.

Jefferson County Community Action Council, Inc. agrees that if the BCDJFS can document evidence that the Jefferson County Community Action Council, Inc. failed to comply with the terms of the contract, the BCDJFS has the right to cancel the contract upon the delivery of written notice of said noncompliance to the Contractor. The Contractor agrees that if breach of contract can be documented, the BCDJFS reserves the right to legal, administrative, and contractual remedies. Cancellation of the contract, for any reason, shall not relieve either party of any financial obligation owed to the other which occurs as a result of or during the course of the contract.

CONFIDENTIALITY

The Contractor agrees that he shall use any information, systems, records, or other materials of a confidential nature, for any purpose than to fulfill the contractual duties specified herein or other duties imposed by law. The Contractor agrees to be bound by the same standards of confidentiality that apply to the employees of BCDJFS and the State of Ohio.

ASSIGNMENTS AND SUBCONTRACTS

The Contractor shall not assign any interest, including subcontracting, in this Contract and shall not transfer any interest in the same (whether by assignment or notation) without the prior written approval of BCDJFS and subject to such conditions and provisions as BCDJFS may deem necessary.

INDEPENDENT CONTRACT

The Contractor agrees that no agency, employment, joint venture or partnership has been or will be created between the parties hereto pursuant to the terms and conditions of the agreement. The Contractor agrees that, as an independent contractor, contractor assumes all responsibility for any federal, state, municipal or other tax liabilities which may accrue as a result of compensation received for services or deliverables rendered hereunder.

Jefferson County Community Action Council, Inc. certifies that no later than the first effective date of this contract, all approvals, licenses or other qualifications necessary to conduct business in Ohio will be obtained. In the absence of such approvals, licenses or other qualifications, this contract shall be void as of the first effective date.

NONDISCRIMINATION

The Contractor may not, in the performance of this contract, discriminate against any employee who is employed in the work covered by this contract, or against any applicant for such employment and Contractor shall not discriminate against individuals because of race, color, religion, age, sexual preference, sex, handicap, or national origin.

RECORDS AND AUDITS

The Contractor agrees to maintain all books, records, documents, and other evidence pertaining to the cost, expenses and records of this Contract to the extent and in such detail as will properly reflect all costs, direct and indirect, of labor materials, equipment, supplies, and services as well, and other costs and expenses of whatever nature for which reimbursement is claimed under the provisions of this Contract, and will follow all county, State of Ohio and Federal record retention policies regarding disposal.

INDEMNIFICATION

The Contractor understands and agrees that it is an independent Contractor and agrees to indemnify and hold the BCDJFS harmless from liability of any and all claims, demands, or suits, in contract or in tort, actual or threatened, and from damages or payments including but not limited to costs and expenses, arising out of breach of contract, acts of omissions of the Contractor and findings for recovery relating to any and all audits.

AMENDMENTS

This Contract may be amended in writing. No amendment shall be effective until such date, as both parties have executed a written agreement.

MISCELLANEOUS

Any notice to the BCDJFS shall be sufficient if sent certified mail, return receipt requested, if such notice states that it is a formal notice related to the Contract. Any notice to the Contractor shall be sufficient if sent certified mail, return receipt requested, provided that such notice states that it is a formal notice related to this Contract.

If there is any publicity releases or other public reference including media release, information pamphlets, etc., on the services provided under this contract, it will be clearly stated that the project is funded under the State of Ohio's WorkForce Investment Act.

In respect to the award and operation of this Contract, the BCDJFS and Contractor agree to comply with all applicable Federal and State laws. This Contract is to be construed, governed and enforced under the laws of the State of Ohio.

Performance of the contract by the BCDJFS is contingent upon availability of State and Federal Funds.

Mr. Pielech stated, " There have been meetings and the by-laws have been approved. This list is a recommendation of five (5) persons and a liaison for the Commissioners to appoint to the Board.
