OPEN PUBLIC FORUM -Mike Bianconi voiced support for the Senior Services Program under the Department of Job & Family Services and also Vince Gianangeli as the Director of DJFS along with combining his jobs. He requested a copy of the Attorney General's opinion

Mr. Thomas asked Mr. Coffland if there was any progress with Steubenville on Monday night regarding the Jefferson Belmont Regional Solid Waste Authority plan. Mr. Coffland said yes and explained the JB Green Team met for about 2 ½ hours with the City of Steubenville and its leaders. It was a committee put together to try to negotiate with them to see what their problems were with passing the new Solid Waste Plan. Mr. Coffland said they feel very confident that after Monday night with a few changes made in the plan, that it will please Steubenville. They will still have to go through the ratification process and hold public hearings. They have been trying to get Steubenville on board for about six months now. Mr. Coffland said it is thought they have now satisfied their wants and are still staying within the plan. The biggest issue was designation fees. They wanted a cap on that and they did cap it at \$2.00. Mr. Coffland said council still has to vote on it, but they feel very confident it will pass. He said the Solid Waste Board has worked very hard to get this plan passed. Mr. Coffland stated, "The important part to remember, if we do not pass it locally, the state will step in and run our Solid Waste Program for us." Within two weeks it should be known if Steubenville is on board. After that the townships will be asked. Mr. Coffland thanked Jefferson County Commissioner Tom Gentile for his hard work in the Steubenville area to try to get everyone on board.

regarding Mr. Gianangeli holding two positions. He was informed the opinion was requested by the Prosecutor, but not received yet.

Mr. Thomas advised the board met with the County Auditor a number of times over the past few weeks. He said the County Engineer has been asked to develop a plan that will look at repairing and paving and then maintaining county roads. When that is complete, the Board will then take a look in January about a formal plan on how and what roads are going to be paved, not just in 2015, but beyond. There needs to be a plan similar to what ODOT does. They do a five (5) year plan. The board is committed in principal to giving the Engineer General Fund money to pave roads. That will begin in 2015. The goal is to get some projects established pretty quickly so that they can go to bid in late winter when prices may be better than in July or August. With the continued good economic times here, we are going to give some of the General Fund money, which is not normally done for roads, and start repairing them. They key would be to maintain them.

Mr. Coffland added that the board asked the Engineer to come up with \$500,000.00 in increments up to \$2 million, which sounds like a lot of money, but in reality you're looking at probably less than 30 miles of road of the 330 that we have, but it is a start-as long as the money keeps coming in. Mr. Coffland also thanked the County Auditor who has been working with the board as he knows this is a priority to this board, and is trying to find some additional dollars. Mr. Sutak stated the communication lines will be open and we'll work together to do what we can for our residents of Belmont County while things are in a pretty good financial state. He said, "Whatever extra we have, that will be applied towards the Commissioners to do those roads and do some other infrastructures that are very highly pending to help move this county in the right place for the next 4 to 5 years where I think our window is open." Mr. Sutak said he has an open door policy to make sure we work together to get things done for the county. Mrs. Favede said the one thing all agree on is the most important thing to our residents is safety in roads, guardrails, fire safety and police. That is something that we are committed to. Mr. Coffland noted the opportunity has not always been but things are better now economically.

Mr. Hord asked about the Land Bank operations manager. Mrs. Favede advised that A.C. Wiethe of Belomar oversaw the Move Ohio Forward Program for the board, and with the Land Bank concept being entirely new, the Belmont County Land Reutilization Committee (BCLRC) is working to contract with him at least for the first year so that they can learn how to operate as a Land Bank and work effectively with the communities. Attorney Richard Myser has been hired to review the contract and the BCLRC will be signing with Belomar for them to oversee the Land Bank Program. The majority of management services will be paid by the grant money from set fees for each demo. She said the BCLRC has to have a Memorandum of Understanding with each community that they are going to demo within. The Land Bank board wants to get an MOU now with every single township, village and city within the county so that they do not have to do that later.
