IN THE MATTER OF APPROVING REQUEST FROM THE TOURISM COUNCIL FOR ADDITIONAL MONIES FOR THE 2013 GRANT PROGRAM

OPEN PUBLIC FORUM – Mike Bianconi said he read in the paper that Jefferson County is getting approximately \$700,000.00 in casino money. He asked what Belmont County might be getting and what the plans are for the money. He strongly encouraged the board to use it on the county roads and for paving. Mrs. Favede advised the board was using that money at this point to do capital improvements. There are quite a few issues in the county that need attention. Discussions have been had regarding a potential levy specifically for roads and bridges. Mr. Probst said he has asked that we take a percentage of the casino monies and put it towards road projects. The board is still having discussion on that. He advised that money may not be guaranteed in the future. He would like to see the money balanced out and not put all of it into capital improvements. Mr. Probst said before the board votes to put a levy on and tax the people more, we should take a look to see how much the estimates are coming in from the casino money and other revenues. He said there is no guarantee that the County Engineer would take the money from a levy and put it into road paving. Mrs. Favede said there are two (2) different levies. There is one the Engineer is asking the board to put on, which he said he couldn't guarantee, but a levy that would be on a referendum would be guaranteed based upon the language that is submitted to the Board of Elections. Regarding the casinos, Mrs. Favede said our Wheeling casino is projecting a \$1 million loss. She said casinos are not turning out the revenue that they expected. Already this year the revenue generated for the casinos in the state of Ohio are showing a 30% loss of what they were projected to. We do not want to create a situation where the county is dependent on that money. Mr. Coffland advised the first casino money went to the courthouse parking lot. The second allotment went for some remodeling upstairs. Mrs. Favede said the governor's proposal will change our potential income based on sales tax because he is reducing our sales tax at the state level. She said she certainly doesn't want to look at this money as "extra" money that we can just give away and then find ourselves losing money. It has been her understanding that because the casino was voted on that the state was trying to figure out what they could take away from county governments to equal what we were getting here; to keep us even keel. We are trying to be very conservative.

Mrs. Favede advised we are receiving complaints about the street lights being turned off in Pease Township. She said this is creating unsafe communities and unsafe roads. She encourages the residents to call and/or write the state. The governor has \$2 billion sitting in a rainy day fund. The money needed by the township to pay their electric bill is sitting in a rainy day fund.

Mr. Bianconi said he is against striping the roads unless they are paved first. He said it's a waste of money. He is for tearing down the Hab Center and building a new building to move county offices into. He would like to keep the senior services program where it is now (under the Dept. of Job & Family Services). He asked if there would be a savings of \$400,000-\$500,000 by splitting it up. Mr. Probst and Mr. Coffland said that would be for one of the programs. Mr. Probst advised it would be in transportation costs. A federal program is a full reimbursement that comes over under us. Mr. Probst said with Human Services, the way they are audited on how much time they spend on senior services and how much on human services, it can't be 100% reimbursed. In order to receive 100% reimbursement on transportation, you would have to be working 100% of the time on transportation alone. He said there is a computer software system, RMS, that monitors this.

11:00 Sue Douglass, Executive Director, Belmont Co. Community Improvement Corporation/Department of Development Re: Update on Fox Commerce Park

Sue Douglass jointly announced with the Commissioners that the sale of all lots in Fox Commerce Park is now complete. The final deed was recorded last week. There are approximately 18 businesses in operation at the 125 acre park. The DOD/CIC has continued interest in property development in Belmont County. Some of the businesses in Fox Commerce Park are multiple entities. Most of those businesses are in some type of operation, even though there are still planning stages going on. In addition, some of the businesses have been there long enough that their longevity has launched them into new ventures. She advised you will be seeing some name changes as second generation businesses go into the park. She gave the following statistics: The project began in 1998 (15 years ago). The first business was Tim's Custom Installation starting in 2005. FedEx entered the park in 2006. She noted the park continues to be a home to small, hometown business as well as large entities that have moved into the area. The park is very diversified and now includes Chesapeake Oil, Gulfport Oil and their support services. Since 2008 there have been 12 businesses added and the number of employees keeps going up. The only county property there now is the park, pond and trails, which she noted have been a very attractive asset in the park. Every business has a minimum of two (2) years to get their business up and operating. The integrity of the park is secured by the fact the (protective) covenants do follow the deed.

Mr. Coffland thanked Sue for her report. He was glad to see things up and moving in the county. Moving into the future, he asked if she had found any land for future development. She responded that they are looking. Development is dependent on infrastructure. She noted a lot of the grant money that had been used is no longer available. The governmental support is not there. It will be a challenge to get the capital investment in a piece of property that you can then promote as an industrial park. Mr. Coffland stated the good thing is land is at a premium value today in Belmont County. Mr. Probst noted that seems to be the trend now; developers are looking for – portable land with available infrastructure. When they need to build, they need readily, available land. Mr. Probst advised we have been having talks about putting that type of package together. We are working with our Water & Sewer Department in different areas of the county where we have some ground that we could sell. Sue stated the DOD/CIC is very happy to work with the county. They are still getting inquiries about property at the park. They are not turning business away from the county; it is just more challenging to find another location now that the park is complete. She advised they will continue to work with every entity that comes to their attention. Mr. Probst advised the board has been looking at forming relationships with the oil and gas people and their executives. He said we have some property on the western end of the county and it is suitable for development. We are looking in that direction until something else opens up locally here, in and around the St. Clairsville area, and the riverfront. Mrs. Favede echoed Ms. Douglass when she said, "It's a new day in Belmont County." When she took office over 4 years ago, the county was struggling. Now the industrial park is sold out, unemployment is down, all of our existing empty buildings are being taken up by new businesses, plus the land in the industrial park is being built upon. She stated we are experiencing economic opportunities unforeseen in the past. In order to capitalize on that, we need a lot of those funding opportunities returned. We cannot afford the sewer and water lines and the infrastructure growth that is necessary to bear the economic growth that is happening. We need the participation of our federal government to ensure the growth of Belmont County, therefore, Ohio. She concluded by saying, "Hopefully, we will be able to have our voices heard there." Mr. Probst agreed with Mrs. Favede. He said the state needs to invest in infrastructure in SE Ohio. He said, "Now is the time. The jobs are here and more are coming."

Port Authority Director Larry Merry commended Sue Douglass on her report and said it shows the long, rigorous process needed to go through to get there. He stated, "We are at that point now, through the efforts of the Commissioners and Port Authority and private sector, in the western part of the county, getting closer every day. There is a property that is basically development ready. The Eastern Ohio Regional Industrial Park (EORIP) is at the point where they are trying to market it for the first time. He noted a lot of the development is happening because of the oil and gas industry.
