 - The review fee is based on hourly staff rate and/or consultant hourly rate based on scope of work of project and available staff per the County Water and Sanitary District discretion. *

- County General Health District (Septic and Well)
 - The review fee is based on hourly staff rate and/or consultant hourly rate based on scope of work of project and available staff per the County General Health District discretion. *

- Planning Department (Coordinate and Review to approved Final Plat)
 - The review fee is based on hourly staff rate and/or consultant hourly rate based on scope of work of project and available staff per the Planning Commission discretion *

Construction Inspection Review Fees

- County Engineer (Street and Stormwater Review)
 - The review fee is based on hourly staff rate and/or consultant hourly rate based on scope of work of project and available staff per the County Engineer discretion. *

- County Water and Sewer District (Water and Sanitary Review)
