Bryan Minder, 9-1-1 Director, said this is just moving forward since the last levy was renewed for an additional five years. They got quotes back in late 2016, early 2017 of what it was going to cost to do the upgrades to the 9-1-1 radio system. The microwave on all six towers in the county, which is the communication for the whole system in the county, will be replaced and the paging system, which is utilized by the fire departments and EMS in the county, will be upgraded so they can receive call for service. In addition to the paging system each tower has a paging terminal at each site that will be upgraded. All fire pagers will also be replaced, they are approximately six years old. Discussion-Road Issues & Severance Tax letter

Present: Belmont County Engineer Terry Lively

Mr. Dutton said they are trying to provide some additional funds to the County Engineer outside of the funds he does have. The gasoline tax has not been altered at the federal or state level for several years. He said the Board decided to increase the license fee and they are looking at other avenues to address the issue. Mr. Dutton said Commissioner Thomas testified, last year, regarding the bill Representative Jack Cera had on the severance tax. They decided to make another push to the legislature to try to have them understand what we are dealing with in Belmont -County as it pertains to oil and gas development and our needs from a road infrastructure standpoint and other issues that have arisen. Mr. Dutton gave a quick summary of the letter that was sent to all legislators in Columbus and the Governor. They are asking for a portion of the funds that are being held in Columbus to be used to assist counties going through the production of oil and gas and will continue to make this push. Mr. Meyer said, "This is the right thing to do for Belmont County. We're just asking for our fair share at the end of the day." Mr. Thomas said the severance tax fund took in \$52.1 million during the state's last fiscal year. He added this letter is to also serve as an educational purpose to educate leaders who may not recognize what is transpiring here in Belmont County. He said a year ago the General Assembly raided the fund \$15 million was taken to settle a flooding lawsuit by landowners in another county. He said that is not what the fund is for. Mr. Thomas said the purpose the severance tax was established was to fix infrastructure and Belmont County deserves its fair share. Mr. Lively agreed the purpose of the severance tax is to help counties affected by oil and gas and we haven't seen it directed where it should be directed. Mr. Dutton said they extended an offer to any legislator to visit and show them firsthand the issues they are discussing in the letter. Mr. Dutton said some legislators say they don't know what happens when money is returned to the counties. He said we'd be happy with strict strings attached saying it could only be used for road issues.

WHEREAS, based on the current cost estimate and schedule for the project, the LPA will not be required to deposit any funds at this time. The LPA's ultimate share of the cost will be determined by the date of construction completion; and

WHEREAS, the LPA is agreeable to cooperate with the Director of Transportation in the above described project; and

WHEREAS, the legislative authority of the LPA desires the Director of Transportation to proceed with the aforesaid highway improvement.

NOW, THEREFORE, be it resolved that:

SECTION I – Project Description

This emergency project description shall be as follows:

Two landslide repairs on C.R. 46: BEL-CR46-1.77 – 100' long drilled shaft retaining wall with associated pavement repairs. BEL-CR46-2.29 – 88' long drilled shaft retaining wall with associated pavement repairs.

SECTION II – Consent Statement

It being in the public interest, pursuant to R.C. 5501.03 and/or R.C. 5501.11, the Belmont County Commissioners of Belmont County, Ohio gives consent to the Director of Transportation to undertake and to complete the above described project.

SECTION III – Cooperation Statement

The LPA hereby agrees to cooperate with the Director of Transportation of the State of Ohio and to participate in all associated costs of the project including preliminary engineering, construction of the identified highway improvement project, together with costs of utility relocation reimbursement, if necessary, and right of way acquisition as needed; and grants consent to the Ohio Department of Transportation for its development and construction of the project in accordance with plans, specifications and estimates as approved by the Director. The LPA shall participate and cooperate with the Director of Transportation in the above described project on the following basis:

The State will apply Federal-aid funds for the financing this improvement from funds allocated by the Federal Highway

Administration U.S. Department of Transportation for emergency highway repairs at One Hundred Per Cent (100%) participation on all costs incurred up to and including on August 11, 2018, with an understanding that participation in financing of all remaining costs incurred after that date through completion of the project by Federal-aid funds will be at Eighty Per Cent (80%), with the LPA participating in such remaining costs at Twenty Per Cent (20%); and The State has estimated that 10% of construction will be completed by August 11, 2018 assuming no major changes in scope or utility delays; and

Therefore, at the time of this legislation and signature of the agreement provided herein, the LPA will not be required to deposit any funds. The LPA's ultimate share of the cost will be determined by the date of construction completion.

The LPA further agrees to pay 100% of the cost of those features requested by the LPA which are determined by the State and Federal Highway Administration to by unnecessary for the Project.

The LPA further agrees that change orders and extra work contracts required to fulfill the construction contracts shall be processed as needed. The State shall not approve a change order or extra work contract until it first gives notice, in writing, to the LPA. The LPA shall contribute its share of the cost of these items in accordance with other sections herein.

SECTION IV—Appropriation of funds

It is not necessary at the present time to appropriate funds of the Belmont County Commissioners for construction of the improvement described above; however, when the final costs are adjusted or additional costs are incurred for change orders, the LPA will arrange for the appropriation of sufficient funds to cover payment of such items upon request and involve by requisition of the Director of Transportation. **SECTION V—Request to Proceed**

The LPA hereby requests the Director of Transportation to proceed with the aforesaid highway improvement.

SECTION VI – Utilities and Right-of-Way Statement

The LPA agrees to acquire and/or make available to ODOT, in accordance with current State and Federal regulations, all necessary right-of-way required for the described Project. The LPA also understands that right-of-way includes eligible utility costs.

The LPA agrees to be responsible for all utility accommodation, relocation and reimbursement and agrees that such accommodation, relocations, and reimbursements shall comply with the current provisions of 23 CFR 645 and the ODOT Utilities Manual.

SECTION VII – Maintenance

Upon completion of the Project, and unless otherwise agreed, the LPA shall: (1) provide adequate maintenance for

the Project in accordance with all applicable State and Federal law, including, but not limited to, Title 23, U.S.C., Section 116; (2) provide ample financial provisions, as necessary, for the maintenance of the Project; (3) maintain the right-of-way, keeping it free of obstructions; and (4) hold said right-of-way inviolate for public highway purposes.

SECTION VIII- Authority to Sign

The County Engineer of said Belmont County, Ohio is hereby empowered on behalf of the

The LPA agrees that if Federal Funds are used to pay the cost of any consultant contract and if the LPA is involved in contracting with such consultant, the LPA shall comply with 23 CFR 172 in the selection of its consultant and administration of the consultant contract. Further the LPA agrees to incorporate ODOT's "Specifications for Consulting Services" as a contract document in all of such consultant contracts. The LPA agrees to require, as a scope of services clause, that all plans prepared by the consultant must conform to ODOT's current design standards and that the consultant shall be responsible for ongoing consultant involvement during the construction phase of the Project. The LPA agrees to include a completion schedule acceptable to ODOT and to assist ODOT in rating the consultant's performance through ODOT's Consultant Evaluation System.

SECTION IX—Emergency action

For the reasons stated in the preamble hereto, which is hereby made a part hereof, this <u>Resolution</u> is

Federal Highways is funding two slip repairs on New Cut Road and it is being done as an Emergency Type A project which means someone can begin work as early as next week. The project does not need to be bid out. If the work is completed by August 11, 2018, there will not be any match money needed by the Engineer. Any work that happens after August 11 will be subject to the 20% match.

Vince Gianangeli, Director, Belmont Co. Dept. of Job & Family Services **Re: School Clothes for Kids Program**

Present: Vince Gianangeli, Jack Regis, Jr. DJFS Budget Officer, D.K. Wright, WTRF, Walter Polivka, 106.3, Jaime Baker, WTOV and Robert DeFrank, Times Leader.

Mr. Gianangeli provided a press release and announced this is the fifth year they will be doing the School Clothes for Kids Program. \$700,000 of TANF funds will be available to serve children whose families are at or below 150% of the federal poverty levels. He noted since 2014, not including this year, over 5,000 children have been clothed through this program.

Dee Phillips, Executive Secretary & Wendy Tronka, Development Director, Wheeling Health Right **Re: Annual Allocation**

Ms. Phillips said they serve almost 22,000 people in the Ohio Valley with health care, medication and dental services and they are expanding their dental services. Ms. Tronka said their second highest population of patients is from Belmont County. She noted they do not get reimbursed for Ohio Medicaid so Belmont County patients are taken care of fully by Health Right funds. They are very appreciative that the Board of Commissioners helps subsidize the program.

The funds the Commissioners put forward in conjunction with Job and Family Services allow them to help families heal and give them hope. Ms. Hawkins said Harmony House is nationally accredited.

Mr. Gianangeli said the Department of Job and Family Services has contracted with Harmony House for seven years. Levy money and the Board of Commissioner's contribution funds that contract. Harmony House helps with the investigation of abuse through forensic interviews.

He explained that lately with some industries coming into town and some of the construction going on, they have had issues with water haulers connecting illegally to their hydrants. It can create discolored water and it is also a public health concern since it can cause breaks or put some customers out of water. Mr. Porter said if a truck is connected to the system and pressure is lost it is going to pull water, potentially, out of that truck and they don't know what was in the truck which causes a health concern. He said they have 1,300 fire hydrants in the system and can't lock all of them so he is requesting the public assistance by reporting this if they see it by calling the Sheriff's department or the water department. Mr. Thomas said the Prosecutor has been notified and if someone is caught they will be prosecuted. The Commissioners will reach out to as many companies operating in the county as they can to remind them of this issue.
