By unforeseen circumstances additional work on the Belmont County Waterline relocation project was needed to complete the project. This work was not described in our bid however it was a lumpsum bid and Belmont County is not accountable for payment within this request. This change order is only a request for additional payment.

The attached is a change order invoice. This change order was for the extra use of stone/rock that was placed in the ditch line where the pipe was placed. The project was time sensitive and while opening the ditch line the ditch itself had to be widened at the top because of the wetness and the ditch caving in. In areas the ditch was 7 feet deep and as stated for safety and work reasons the ditch opening was larger than planned therefore leading to more stone/rock to be placed back into the ditch when padding and closing. Stone quoted for the project was 934 ton. Stone used was 1151 tons. We are not requesting any additional payment for time and man hours, only the extra stone used.

If you could find to approve said change order it will be appreciated.

Courthouse Security Upgrades

Present: Chief Deputy James Zusack, Belmont County Sheriff's office and Deputy Tim Scott. Deputy Jen Yuhase and Deputy Rick Schimmel joined later. Deputy Scott gave an overview of the security upgrades that was done on the camera system and door locks. He oversaw the security improvements. Deputy Scott said the new system can be expanded in the future. He said he feels the building is very secure for the employees and public. Mr. Dutton said he appreciates all the work that was done and he feels there is a great level of security in the courthouse. He added the employees will have training sessions on lockdown procedures. Mr. Meyer said the courthouse security does a fantastic job and appreciates them for the work they do. Chief Zusack presented a plague to Deputies Scott, Yuhase and Schimmel in appreciation for all they do keeping the building, staff and public safe.

RECESS

IN THE MATTER OF COVID-19 UPDATE- Rob Sproul, Deputy Health Commissioner, said there are 302 positive cases in the county, one hundred twenty-three of those are out of quarantine, nine hospitalized and seven deaths. Mr. Sproul said they did a training at Senior Services of Belmont County regarding the precautions the staff can take when providing meal delivery and transportation. Mr. Dutton said, "It is important to remember the things we started off with in the beginning, those things are just as true or more true now as things open up and there's more interaction. The hygiene, the masks, those things will remain pretty important as things continue to open back up." He added the local business community is doing everything in their power to open back up safely and the Health Department is providing a lot of guidance. Mr. Sproul said, "The virus today is the same as it was months ago. It's still here. The numbers are still increasing." Mr. Meyer questioned if the rise in the number of cases is due to the cases at the Belmont Correctional Institution. Mr. Sproul said yes, that is the biggest share of new cases. Mr. Meyer said people are recovering and getting healthy, use common sense, wash hands, basic hygiene will reduce the spread.
