Mr. Dutton gave a procedural update. He said things are operating the same here, in terms of county buildings, they continue to evaluate that on a day by day basis. The buildings, in most cases, remain open to the public by appointment only. The public is asked to call ahead, to deal with issues remotely if possible or if they need to come to the courthouse that remains available to them. Mr. Dutton said they appreciate the public's patience throughout this and hopefully it hasn't interfered with people's interaction with county government. He added they are trying to remain cautious and conservative. Mr. Dutton said they also will continue to evaluate keeping their meetings at 10 or less. "We are kind of proud, we've kept our meetings as close to normal as possible throughout this entire process. It was very important for us to try to keep this as normal as possible within reason," he said. Mr. Dutton noted the cleaning staff cleans before and after the meetings. He said they will continue to have the live feed in the hallway and will rotate people in and out as needed so everyone has the opportunity to address the board if they want to. "We try to balance between safety for everyone and trying to keep our meetings operating as close to normal as possible," said Mr. Dutton.

Motion made by Mr. Dutton, seconded by Mr. Echemann to approve and sign the Memorandum of Understanding between the Board of Belmont County Commissioners and the Belmont County Animal Rescue League regarding the provision of Humane Officer duties.

MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (hereinafter "MOU") is entered into as of the date last signed by the parties hereto and between the Board of Belmont County Commissioners, Belmont County, Ohio, (hereinafter "the Commissioners"), a body corporate and politic of the State of Ohio, and the Belmont County Animal Rescue League (hereinafter "BCARL"), an Ohio corporation not-for-profit that is actively engaged in the promotion of care of domestic animals in Belmont County; and BCARL is a county society organized under Ohio Revised Code Section 1717.05. The Commissioners operate the county animal shelter ("Shelter") located at 45244 National Road, St. Clairsville, OH 43950. WITNESSETH

WHEREAS, the parties mutually recognize the importance of investigating and prosecuting any person guilty of an act of cruelty to animals; and,

WHEREAS, one of the objectives of BCARL is the inculcation of Humane principles and the enforcement of the laws for the prevention of cruelty to animals; and,

WHEREAS, BCARL is authorized to appoint agents for the purpose of prosecuting any person guilty of an act of cruelty to animals; and

WHEREAS, BCARL has agreed to provide an individual(s) to perform the duties of Humane Agent pursuant to Ohio Revised Code Section 1717.06; and,

WHEREAS, BCARL has agreed to appoint one or more Humane Agents through the Belmont County Probate Court; and, BCARL desires to assume the responsibility for enforcing the animal cruelty laws for and prosecuting the violators thereof; and,

WHEREAS, the Commissioners support the endeavors of BCARL to enforce the animal cruelty laws; and,

WHEREAS, Ohio Revised Code Section 1717.07 provides that the Commissioners shall be responsible for a reasonable salary for Humane Agent in an amount not less than twenty-five dollars per month; and,

WHEREAS, the Commissioners and BCARL have agreed that BCARL will continue to work on enforcing the animal cruelty laws and that the Commissioners will be responsible for the payment of a reasonable salary for the work performed as set forth herein.

NOW THEREFORE, in consideration of the mutual covenants and conditions and promises set forth herein. The Commissioners and BCARL do hereby agree as follows:

I. ENFORCEMENT OF OHIO'S ANIMAL CRUELTY LAWS

- 1. BCARL shall be responsible for complying with current law in appointing appropriate individuals to serve as Humane Agents for the purpose of enforcing animal cruelty laws. BCARL shall assure that any Humane Agent duly appointed by BCARL and approved by the Probate Court pursuant to this contract shall maintain accurate records, including case reports and compilations of all calls, reports, and animal cruelty investigations, prosecutions, and the care and disposition and of any animals seized by the Humane Agent.
- 2. To assist the Humane Agent in his/her duties, County shall make available to BCARL a YELLOW TRUCK and TRAILER more particularly described on Exhibit A attached hereto and made a part hereof by incorporation. The YELLOW TRUCK and TRAILER shall be available for BCARL's use. BCARL shall ensure that the YELLOW TRUCK and TRAILER are only operated by qualified, licensed, and insured individuals, and BCARL shall provide such policies as required by, and insurance satisfactory to, Commissioners, naming Commissioners as an additional insured on said policy. The YELLOW TRUCK and TRAILER shall be utilized during the term of this agreement and any extensions thereof, but shall promptly be returned to the County upon expiration of this agreement.

II. PAYMENT PROVISIONS

1. As reimbursement to BCARL for the cost of one or more Humane Agents, and pursuant to Ohio Revised Code Sections 1717.05 and 1717.07, Commissioners shall pay to BCARL during the term of this agreement the sum of Fifteen Thousand Dollars (\$15,000.00) in monthly payments of One thousand Two Hundred and Fifty Dollars (\$1,250.00) each, which shall be paid on the <u>1st</u> day of the month. Throughout the term of this contract, the parties understand and agree that this monthly payment shall be for the first Twelve (12) months only, and that should a new contract be entered into upon termination of this contract, or should this contract be extended, the County will endeavor to reduce the monthly sum paid as reimbursement for the Humane Agents. BCARL will work with Commissioners to see that said sum is reduced. The Commissioners and BCARL understand and agree that any individual with whom BCARL contracts to serve as Humane Agent shall not be an employee or agent of Commissioners, and shall not report to or take direction from the Commissioners or any of Commissioners' agents.

III. DURATION

1. The initial term of this agreement shall be Twelve (12) months commencing upon execution of this agreement. The parties anticipate working together in an attempt to continue the relationship, but neither party shall have the right to renew or extend this agreement without the mutual consent of the other. Either party may terminate this agreement without cause upon Thirty (30) days' notice in writing to the other party. All notices pursuant to this agreement shall be in writing and hand delivered to

IV. MISCELLANEOUS

- 1. **GOVERNING LAW** The laws of the State of Ohio shall govern this agreement and any performance hereunder; and, venue shall be Belmont County.
- 2. **AMENDMENTS** This agreement may only be amended in a writing signed by both parties.
- 3. **PREVIOUS AGREEMENTS** On the date of execution, this writing constitutes the entire agreement between the parties with respect to all matters herein. There are no promises, terms, conditions, or obligations other than those contained within this agreement. This Memorandum of Understanding shall supersede all previous communications, representations, contract, or memorandum of understanding, either written or oral, between parties and specifically replaces any and all previously executed Memorandum of Understanding entered into between the parties regarding Humane services.
- 4. **SEVERABILITY** If any provision of this Memorandum of Understanding shall be determined by a court of competent jurisdiction to be invalid or unenforceable, the remaining provision shall not be affected thereby the remaining provisions shall continue to be valid and enforceable to the fullest extent permitted by law.
- 5. **COPIES** This Memorandum of Understanding shall be executed in duplicate with an original to be retained by each of the parties hereto.
- 6. **PREVIOUS APPOINTMENTS** The three (3) Humane Agents being Carrie McElroy, Pria Myers and Bradley Troy shall continue to serve as Humane Agents at the discretion of BCARL. BCARL has the right to cause the appointment of additional

Humane Agents, and notice of the appointment of each shall be given to the Belmont County Commissioners immediately upon appointment.

Mr. Dutton said this is a continuation of the MOU from last year. Humane Officer duties, by the Ohio Revised Code, is the responsibility of a recognized Humane Society in the county which the Belmont County Animal Rescue League (BCARL) is. He said for the past year they have been working on those duties. The last MOU there was some access allowed to the Animal Shelter for the housing of some animals for short stints. BCARL now has their own facility so that is no longer needed as part of the MOU. Mr. Dutton said, "We look forward to continue working with BCARL, the humane issue is one that is very important to the welfare of animals in Belmont County and we hope to continue this moving forward."

OPEN PUBLIC FORUM-Richard Hord, Martins Ferry, inquired about the financial impact due to COVID-19. Mr. Dutton said it is too early to tell, but there was a decrease in revenue in March. He said they meet with the Auditor weekly for the latest information. They are trying to keep all options on the table and will know more further in the year. He said he hopes the conservative decisions the board has made over time will help lessen the burden. Mr. Dutton said, "It's going to be an impact. You can't have as many local businesses close for the amount of time they were closed and not expect a repercussion." He noted the county cannot carry a deficit; the budget has to be balanced. Mr. Meyer said the federal government has put out some money as well, we are not 100% sure exactly what the money will be able to be used for. He added a lot of that has to do with COVID related expenses which may lessen the blow.

Mr. Hord asked if PTT Global delaying their decision on the proposed Cracker Plant had anything to do with COVID. Mr. Dutton said they reached out to the board and are very good at communicating where the project is at certain points or when questions arise. He said PTT put out a press release in April speaking to COVID-19 and the impact it was having on the project. They are working diligently to try to come to a final decision this summer and COVID-19 has slowed their work to a certain extent, there are certain aspects of what they need to complete wasn't possible with the current environment. He said work is still being done.

Frank Papini, St. Clairsville, reminded everyone the census is still ongoing and it's very important.

RECESS

COVID-19 UPDATE- Rob Sproul, Deputy Health Commissioner, said there are 433 positive cases in the county, 330 of those are out of quarantine, four are hospitalized and there have been twelve deaths. He said, as of Friday, 1,924 Belmont County residents were tested at the tents in Wheeling, 155 of those came back positive. You can view all guidelines on Coronavirus.ohio.gov. You can also see who is on the committees who comes up with the guidelines which is a diverse group. Mr. Sproul said the local levels than enforces the guidelines. He noted they had very limited complaints on the restaurant openings. Mr. Dutton said the work groups are predominately private entities and are pretty diverse. He said in his opinion the state has been very detailed throughout this process. Mr. Sproul said starting June 1, Ohio Hills Health Center in Barnesville will start doing anti-body testing. Mr. Dutton said masks are still being worn in the county buildings by county employees, they are not required by the public, but it is recommended. Mr. Sproul said masks do help keep the numbers down and if the numbers are down more things will open back up. He noted the National Guard will be helping with testing in the nursing homes.
