This agreement will be effective from July 1, 2020, through June 30, 2021 inclusive unless otherwise terminated.

GENERAL REGULATIONS

- Provider agrees that the use or disclosure of any information concerning qualified recipients for any purpose not directly related to the А. delivery of purchased services is prohibited except upon written consent of the recipients or their guardians.
- The Provider understands that this written agreement supersedes all oral agreements. В.
- C. The Provider agrees to hold harmless the County Department of Job and Family Services, the Board of County Commissioners of the county in which the Department is located, and the Ohio Department of Job and Family Services against all liability, loss, damage, and/ or related expenses incurred through the provision of services under this agreement.
- D. The Provider agrees that in the performance of this agreement there shall be no discrimination against any client because of race, color, sex, religion, national origin, or handicapped conditions as specified in the Civil Rights Act of 1964 and the Rehabilitation Act of 1973 and all subsequent amendments. It is further agreed discrimination and the right to and method of appeal will be made available to all persons served under this agreement.
- E. In the event Provider receives an overpayment, Provider agrees to repay the Belmont County Department of Job and Family Services the amount to which he/she was not entitled.
- F. In the event that state and/or federal reimbursement is no longer available to the Department, therefore, requiring changes or termination of this agreement, such changes or termination will be effective on the date that state and/or federal reimbursement is no longer available, or, later as otherwise stipulated by the Department. This agreement may be terminated by the Provider or the Department upon seven (7) days written notice. Failure to honor the terms of this agreement and/or related state, federal, or local regulations shall result in the immediate termination of this agreement. If any of the terms of this agreement change, the Provider must notify the Department immediately.
- G. Policy that the Provider agrees to adhere to all applicable rules and regulations in the Administrative Code governing service delivery, including insurance.
- H. Eligibility for Services: The County Department of Job and Family Services will determine eligibility for all service recipients directly. Eligibility of individuals to receive purchase services shall be determined in accordance with the policy and procedures established by the Ohio Department of Job and Family Services in the Administrative Code.
- I. Amendment of Agreement: This agreement may be amended at any time by a written amendment signed by both parties and submitted to the Ohio Department of Job and Family Services in the manner required by state regulations.

PAYMENT PROCEDURES

The Department of Job and Family Services agrees to pay the Provider \$ actual cost per gallon Unit for Transportation.

The maximum amount billable under this agreement is \$10,000.00.

- The Provider understands that the payment for all services provided in accordance with the provisions of this agreement depends upon the availability of county, state, and federal matching funds.
- The Provider understands that a recipient, for whom services are provided, may be required by the Department of Job and Family Services. Other than this fee set by the Department, no additional fees may be charged for services rendered under this agreement.
- The Provider agrees to submit an invoice to the Department monthly within five (5) working days following the last working day of the billing period. The Department agrees to review the invoices and authorize with adjustments, if needed, reimbursement for services provided within fifteen (15) to twenty (20) working days of the receipt of the invoice.

Duplicate Billing: Provider warrants that claims made to the County Department of Job and Family Services for payment for purchased services shall be for actual services rendered to eligible individuals and do not duplicate claims made by provider to other sources of funds for the same service.

OPEN PUBLIC FORUM-John Drewitt, Lashley Hill Road in Shadyside, asked if the board has tried to get any money to repair his road, it is in terrible condition. Mr. Dutton said they continue to talk to the County Engineer; the process goes through his office. "We have spoken to some federal contacts on our own trying to find out why the process with FEMA and the regional office in Chicago, seemingly, is taking some time to get through these projects. It is not just a Belmont County issue, there's others in our region that is having the same difficulty," said Mr. Dutton. Mr. Drewitt questioned the money being spent on the new judges' building. Mr. Dutton said some entities that moved to that building were paying about \$110,000 a year in rent so they thought it was beneficial to not pay that cost. He said Western Division Court was to be a temporary space when they moved in about 30 years ago. It is not handicap accessible; it is not really set up to be a court. All three courts are being consolidated into one central place with the County Prosecutor. "It is a great project for Belmont County for the future. It is an expensive project; it is the most expensive building project Belmont County has taken on. We don't take that lightly, but two years in it is roughly 25% paid off. We are putting a lot of work into those buildings, we don't want them to be an issue for a board 2,3, 4 years from now. We want them to be set up for the next 10 plus years or so. I'm very proud of that project," said Mr. Dutton. He added one of the primary roles of a County Commissioner is to oversee county buildings and make sure they are doing things that makes sense in the future so you don't have things like the County Home or the Hab Center or Oakview buildings that gets neglected for a very long time because no one wants to take on a new project because they are afraid of what people may think if you take on a project. Instead you end up with projects that become dilapidated and become evesores and now we're trying to find funding to tear down. Mr. Dutton said on the road projects they have talked a lot about what they have done. Mr. Dutton said, "I know it sounds like passing the buck, but we are not the County Engineer. The County Engineer is also an elected official, just like we are. He gets his funding from two sources which has nothing to do with our board. It comes from gasoline taxes and license plate fees. Both filter through from Columbus, they do not pass through this board, whatsoever. We have no obligation to provide General Fund dollars for county roads, but we have. Prior boards before us has and this board has." Mr. Drewitt said he feels more oil and gas dollars should be kept in Belmont County. Mr. Dutton said the board has sent letters to Ohio House and the Senate members stating that. He said he has also met with the head of the Ohio Oil & Gas Association pleading our case on what they think should be done with the severance tax dollars and has even mentioned it to the Governor's office. "We are advocating for county roads as much as we can," said Mr. Dutton.

Richard Hord, Martins Ferry, asked how the 2020 Census was progressing. Mr. Dutton said census workers are going door to door now and hopefully the numbers get to where they need to be.

Ms. Dickerson said COVID has definitely affected the 4-H program, but they will still be having the Jr. Fair and are taking all precautions they possibly can. Ms. Antill said they had the same amount of kids doing the 4-H livestock projects, but as COVID has continued some of the kids have decided not to bring their projects to the fair, but they did complete them. She said they have been trying to run things as close to normal as possible. Ms. Dickerson said the kids will still show their animals and awards will be given. Mr. Dutton said it is not easy to do a project in the first place, it takes time, hard work and dedication and they deserve some recognition. Mr. Campbell said they are very proud of the Jr. Fair members; they have worked very hard. He said with the support of the community, the Commissioners, the Health Department and Tourism they have got a lot of improvements done. Mr. Dutton said Belmont County's Fair facility is the envy of many across the state. Ms. Cawthorne said this is her first year as Jr. Fair Board Coordinator and Greg Mehlman is her co-coordinator. Ms. Alyssa Betts said the Sr. Fair Board has been working very closely with Belmont County's Health Department to make sure all of the guidelines are being followed so they can have the Jr. Fair. They have invested in hand sanitizing stations; the bleachers will be sanitized before and after every show and signs were purchased to enforce social distancing. Ms. Sierra Betts said a lot of events have been cancelled this year, but they are still hosting the opening ceremonies. Ms. Phillips they will still be have the Jr. Fair show and sale. Ms. Garrison said there will be a 10:00 curfew each night at the fair. Ms. Burress said they are excited to be having a fair and to get to show their animals. Mr. Dutton said many aren't aware of the amount of work they do and the role they play for the fair. They do a lot of work behind the scenes and are a big asset to making the fair happen.

COVID-19 UPDATE- Rob Sproul, Deputy Health Commissioner, said there are 691 positive cases, 616 recoveries, 47 isolated, four are hospitalized and 24 deaths. He said the county is still in the yellow stage, changes are made to the color chart by the Governor's office on Thursdays. Mr. Sproul and his department will be working with school districts on the upcoming sports season. At this point Governor DeWine is allowing contact sports. They are waiting on final orders from the state. Mr. Dutton asked if they are hearing more questions and concerns from the schools or parents. Mr. Sproul said both, everyone is doing the best they can to adapt to the situation. He said take all of the precautions that you can. Mr. Sproul said the schools are allowing for kids to do school virtually, but most kids are going back into the classroom.
