Rob Sproul, Deputy Health Commissioner Re: COVID-19 Update

Rob Sproul, Deputy Health Commissioner, said there have been 1,014 positive cases, 751 recoveries, 232 are in isolation, six are hospitalized and 25 deaths. Mr. Sproul said, "We've got a ton of people quarantined, so we've been doing contact tracing. We're running into issues of trying to get a hold of people. The labs are so backed up, they're contacting the people before they're sending us the paperwork for us to be able to isolate them, so that's been a nightmare. We can't isolate somebody until we have the documentation." They are in the process of hiring another contact tracer. He noted the reported cases are linked to hair salons, nursing homes, schools and gatherings. He said the schools are being proactive to try to slow the spread down. Mr. Echemann commented even though there has been an increase in cases, there have not been any additional deaths. Mr. Sproul said the hospitals are more familiar on how to deal with it. Mr. Dutton asked what was the latest guidance from the state. Mr. Sproul said to continue social distancing, wearing masks and hand washing. The Governor is reaching out to each county. Mr. Dutton encouraged the public to be as cautious as possible. Mr. Sproul added there has been no issue with the availability of tests.
