This Memorandum of Understanding, effective January 1, 2021 until December 31, 2021 is entered into by and between the Belmont County Local Emergency Planning Committee (LEPC), 68329 Bannock Road, St. Clairsville, OH 43950, and the Board of Belmont County Commissioners (Commissioners) 101 West Main Street St. Clairsville, Ohio 43950, for purpose of promoting public safety and prudent emergency planning for the citizens of Belmont County, Ohio.

In consideration of the services to be provided by the Director and staff of the Belmont County Emergency Management Agency as described below, the LEPC agrees to provide the sum of twelve thousand eight hundred and ten dollars (\$12,810.37) annually, provided that (1) the LEPC has such amount, and (2) said sum does not exceed 75% of the fund balance. Said funds shall be made available to the Commissioners during the first quarter of each calendar year this agreement is effect.

In consideration of the funds provided by the LEPC to the Board as described in this agreement, the EMA shall provide the following services to or for the LEPC:

- 1. Grant writing and administration
- 2. Administration of SARA Title Ill filings by local chemical facilities
- 3. Compliance and enforcement of SARA Title III regulations
- 4. Compliance with SERC mandated reports
- 5. Emergency response to spills and releases of regulated materials
- 6. Information coordination of LEPC public records
- 7. Plan development, review, and updates
- 8. Annual exercise of the LEPC county plan and emergency response
- 9. Administration of the LEPC Cost Recovery Program

10. Such other administrative duties as may be needed, provided that such additional duties shall not interfere with nor impede the discharge of the emergency management responsibilities of the EMA Director and staff

The parties stipulate that funds provided by the LEPC to the Commissioners shall be used to supplement existing funding for salaries, benefits

and other operational expense categories of the EMA; and that said funds are being provided by the LEPC to the Commissioners on the condition that such funds shall be used in addition to, and not as a replacement of, funding currently budgeted by the Commissioners to the EMA.

Each party hereto reserves the right to revise or terminate this Memorandum of Understanding annually prior to the anniversary of the date of the signing. Unless terminated, by either party upon written notice to the other not later than 30 days prior to the anniversary date, this agreement shall be in effect for the calendar year.

OPEN PUBLIC FORUM-Richard Hord, Martins Ferry, inquired about if the injection well is still going in at Route 40 and Exit 331. Mr. Dutton said there is activity commencing. He said, "Personally, for me, there is extreme disappoint in the state in terms of how they have communicated with us, particularly in the last few weeks or months. We sent a letter back in February expressing some disappointment to the Ohio Department of Natural Resources saying that with all of the conversations we have had with them prior to granting the testing permit that they didn't have the decency, in my opinion, to at least let us know they were granting the permit and where the next step was going to go. We had communicated that in the letter and asked them to reach out to us and explain where this is going from this point forward because there has been a lot of community concern about the project. It has been about six weeks and we have not received a response back. It feels as though the state, in my opinion, is not having proper communication for all of the communication we have sent them in the last eighteen months." Mr. Meyer agreed the communication with us from ODNR has been very poor. Mr. Dutton added there is a rig on site today.

Keith Sommer, Belmont County District Library Board member, requested the appointment of John Davies to the District Library Board to fill

an unexpired term.

Oil & Gas Industry update

Present: Larry Merry, Belmont County Port Authority Director and Mike Chadsey, Oil and Gas Association Director of Public Relations. Mr. Merry said there has been a little downturn of oil and gas activity recently which is typical. It is a commodity, so when price goes up and down, activity goes up and down. He said it is amazing from a few years ago the improvements made to the roads, literally millions of dollars have been invested. Farmers have made improvements to their property with lease money or royalty money coming in. Mr. Merry said, "The industry, in my opinion, as a whole, has been a great positive to this community, not only in royalties and lease payments, but also in jobs. There is still a tremendous amount of jobs remaining in this community, literally hundreds and hundreds of jobs that weren't here ten to twelve years ago. The average oil and gas job pays about \$40,000 more than the average job in Belmont County." Mr. Merry noted he is on the Oil and Gas Association board. Mr. Chadsey said, "There has certainly been a lot of talk recently in the press about what the industry's impact has been in Eastern Ohio and I'm here to say we have a long and proud history of development here in Eastern Ohio." The first oil well in Ohio was in Noble County in 1814. He said shale development is sort of the next great chapter in our oil and gas story. The first permit was issued to Chesapeake in 2010 to 2011 in Harrison County. Mr. Chadsey said they are now several thousand wells in, a lot of processing and pipeline facilities have been built to handle that gas. He said, "One of things that our message has always been is as much as we have seen the last ten years there is that much more ahead of us. We continue to build our manufacturing base." Mr. Chadsey said they have about 208,000 employees in Ohio that work directly in the oil and gas industry. He said the industry has paid about \$141 million in ad valorem tax which has benefited the State of Ohio. Mr. Chadsey said there are certainly some challenges out there. He thinks they need to do a better job of working with operators to make sure they are being a good community partner and make sure they are following the regulatory code. Mr. Echemann asked what Mr. Chadsey felt the effects would be from the new administration coming in. Mr. Chadsey said they have seen some pretty dramatic impacts. He didn't think there would be much impact here in Belmont County for any particular pipeline, but some of the other things the new administration has done has been more problematic, particularly the federal ban on federal leasing which they expect will become a permanent ban. This will take about 25% of production off the table so you will probably see some price increases. He said you will continue to see discussion on climate change which they recognize as a challenge. He added they don't agree it's a climate crisis. Mr. Chadsey said, "Our message has been to the President that we will work with you when we can, we will oppose you where we must, but don't forget we are part of the solution of climate change, not part of the problem." Mr. Dutton said to look at it optimistically, these decisions affect different parts of the country differently. He asked what is the near and long term future with the industry. Mr. Chadsey replied, "When you can't drill in the Gulf or you can't drill in Wyoming you've got to do it somewhere, which is an opportunity for this area. Ohio is a good place to do business, there is a common sense regulatory structure here and the rock is really good. Those three things makes for a pretty good scenario. I think there is reason to be cautiously optimistic that we have a bright short and long term future here." Mr. Dutton said even at the lowest of lows, from a pricing standpoint, activity never stopped here locally which shows the strength of the industry moving forward. He added the industry had a direct impact on our area with jobs, ad valorem taxes and the Road Use Maintenance Agreements. Mr. Dutton said other benefits are from hotel stays, that funding goes directly to local communities for local fairs and festivals. The sales taxes from gas stations and restaurants changes how the county operates in terms of things they do. He added there is a correlation between the county's financial stability and the oil and gas industry. Mr. Chadsey said they are showing today's students you can stay here and you can make a good living. New curriculum programs have been added in local colleges.
