IN THE MATTER OF ENTERING INTO CONTRACT BETWEEN THE MENTAL HEALTH RECOVERY BOARD AND BELMONT COUNTY COMMISSIONERS/JAIL

Motion made by Mr. Echemann, seconded by Mr. Meyer to enter into contract between the Mental Health Recovery Board and the Belmont County Commissioners, effective September 1, 2021 to June 30, 2022, to support the delivery of mental health and substance abuse services to inmates of the Belmont County Jail.

Note: The Mental Health Board will compensate the county up to \$125,000.00 per year for services.

This Contract is entered into between the Mental Health and Recovery Board, Belmont, Harrison, and Monroe Counties, 99 North Sugar Street, St. Clairsville, Ohio herein referred to as "BOARD" and the Belmont County Commissioners, 101 West Main Street, St. Clairsville, Ohio, herein referred to as "COMMUNITY PARTNER".

I. <u>Purpose:</u>

The purpose of this contract is to support the delivery of mental health and substance abuse services to inmates of the Belmont County Jail and establish the control of those services internally with the Community Partner. Additionally, the purpose is to continue the linkage of inmates to community providers and resources outside the jail, upon release.

The outcomes for these funds are:

- 1. Increase access time for inmates to receive behavioral health services on-site.
- 2. Enhanced linkages made upon release for inmates to community-based providers.
- 3. Enhance on-site crisis intervention with inmates.

II. Duties of the Community Partner:

The Community Partner will purchase:

- 1. Mental health and substance abuse counseling services from an Ohio licensed independent counselor (LPCC) or licensed independent social worker (LISW).
- 2. Complete a quarterly report due on October 15, 2021, January 15, 2022, April 15, 2022, and July 15, 2022. (See attached report)
- 3. The COMMUNITY PARTNER will submit quarterly invoices of expenses to the BOARD.

III. <u>Independent Contractor:</u>

In performing the services herein specified, Board agrees that neither the COMMUNITY PARTNER nor any of the employees of the COMMUNITY PARTNER are employees of the Board. Nothing contained in the Contract shall be construed to create a partnership or a joint venture between BOARD and COMMUNITY PARTNER, or to authorize either BOARD or COMMUNITY PARTNER to act as a general or special agent of the other party in any respect, except as specifically set forth in this CONTRACT.

IV. Duties of the Board:

- 1. The BOARD shall compensate the COMMUNITY PARTNER up to \$125,000.00 for activities/services under this agreement including but not limited to:
 - Direct Service Personnel Salary
 - Direct Service Personnel Fringes
 - Insurance
 - Travel
 - Continuing Education
 - Office Supplies
 - Equipment (Desk, Chair, Computer, Phone)
- 2. This contract will be in effect from September 1, 2021, to June 30, 2022.
- 3. The MHR Board shall advance the COMMUNITY PARTNER three quarters of the total contract or \$93,750.00.00 and will reconcile the year to date expenses to revenue to determine the amount of the remaining 4th quarter installment.
- 4. By the eighth day of the month following the end of the quarter, the COMMUNITY PARTNER will submit a detailed invoice of all actual expenses for the preceding quarter to Wendy McKivitz, Fiscal Officer, wendym@bhmboard.org
- 5. The Board's fiscal officer will reconcile submitted quarterly invoice and detailed expense report with projected budget expenses.
- 6. A third quarter reconciliation will be completed to determine if a fourth quarter payment is supported.

V. Termination

- 1. Either party may terminate this Contract if all the conditions in this Section are met.
- 2. The party seeking to terminate the Contract shall give not less than sixty (60) days prior notice in writing. Such notice shall be served by certified mail, and return receipt requested.

VI. Amendment and Modification

The parties may amend or modify this Contract at any time provided that such amendments or modifications are in writing, approved by both parties, signed by both parties, and attached to this Contract.

VII. Severability

Should any portion of this Contract be deemed unenforceable by any administrative or judicial officer or tribunal of competent jurisdiction, the balance of this Contract shall remain in full force and effect unless revised or terminated pursuant to Article 5 of this Contract.

Any notice required to be given in this Contract shall be deemed to have been properly served if the notice is in writing and delivered by certified mail, and return receipt requested.

IX. Entire Contract

It is acknowledged by the parties hereto that this Contract supersedes any and all previous written or oral Contracts between the parties concerning the subject matter of this Contract.

X. Governing Law

This Contract shall be governed by and interpreted in accordance with the laws of the State of Ohio.

Discussion-OPWC applications-BEL 5-13.52/17.60 Jacobsburg-Glencoe-St. Clairsville and BEL 26-0.00/1.25 South 26 Paving Project and BEL 44-1.13/4.30 Winding Hill Road Project-County Engineer Terry Lively said he is going to submit two paving projects this year. Project BEL 5-13.52/17.60 and BEL 26-0.00/1.25 is approximately 5 miles of paving. BEL 44-1.13/4.30 is for a total of approximately 3.17 miles of paving. This is the first step in the process. Mr. Lively said it is a competitive program, the next step is going to the County committee and then on to Buckeye Hills, who administers the OPWC program for review and the selection process.

Discussion-Mental Health Recovery Board contract-Lisa Ward, Mental Health Recovery Board Director, said they have been meeting with the Sheriff's Department and the Board of Commissioners regarding mental health and substance abuse issues. The counselor will screen new inmates and identify those needing services, get them out of jail and into treatment. Ms. Ward said, "One of the things I love about Belmont County is their spirit of collaboration. This is a great moment, I think, for our systems of care, both criminal justice and behavioral health." They will be looking for an independently licensed therapist or social worker. Sheriff Lucas said, "This is a daily ongoing problem with us. It is sad that we are in the 21st century and we are having more problems now than we had 20, 25 years ago." He said local entities arrest individuals who are disorderly and bring them to the jail like a dumping ground. Sheriff Lucas said, "They don't need to be in jail. They need help and assistance." Jail Administrator Stan Galownia said finding treatment for these inmates is complicated. He added there has been an uptick in mental health issues.

OPEN PUBLIC FORUM-Richard Hord, Martins Ferry, asked for the Commissioners' comments on the 2020 Census and Belmont County's loss of 5.5% of residents. Mr. Echemann said they don't like to see population decline and they will do anything they can as a board to create an environment in the county where more people want to move here. Mr. Dutton said the county, as an entity, is in a stronger position today than ten years ago. He feels there has been a positive impact with the oil and gas industry in terms of infrastructure improvements and family farms that are now still in existence that were maybe teetering and they have been able to make improvements. Mr. Dutton said, "I think there is a stronger base than there was ten years ago. I think we are seeing that with the infrastructure improvements we are trying to do as a county, whether it's water or sewer, road projects and the broadband project going on right now. That is what you do to try to stem population loss, you try to make sure you have a strong foundation to build off of. Hopefully, ten years from now that decline starts to slow down or move in the other direction."
