Discussion re: Keefe Commissary Network agreement-Present: Sheriff Dave Lucas and Jail Administrator Stan Galownia

Mr. Galownia explained the jail has been in business with Keefe since 2018. They receive 28% of the adjusted gross profits which has to be spent on something that benefits the inmates. Last year they purchased two 15 seat transport vans. The inmates are provided three meals a day, but can purchase items from the commissary. The items that are available for purchase is decided on by the jail.

OPEN PUBLIC FORUM-Martins Ferry Council President Kristine Davis submitted a resolution in support of Belmont County Senior Services working with East Ohio Regional Hospital (EORH) to provide healthcare services for the seniors and also in support of the upcoming Senior Services levy renewal. Ms. Davis said Martins Ferry Council would appreciate the Commissioners' consideration in including EORH for providing services. Martins Ferry Mayor Davies said that he is here in support of East Ohio and also in support of all facilities, the hospitals, the clinics and everything else. He doesn't think it is right to partner with just one group. Mr. Echemann said, "It was not a decision to exclude and it is not an exclusive arrangement that we have with Wheeling Hospital. We're more than happy going forward to involve East Ohio Regional. We want to let everybody know that." Mr. Echemann noted Senior Services Director Dwayne Pielech will meet with EORH when he returns from vacation. Mr. Dutton said, "I think there's been a lot of misinformation about this agreement. There's no contract in place. There's no money changing hands between Belmont County and the hospital. It's not exclusive. We contract with a lot of different entities. Senior Services is a big program. We're going to continue to do that. We're going to continue to try to have services that are beneficial to the residents. No one's been pushed off to the side and no one will ever be pushed off to the side in terms of working with Senior Services." Mr. Dutton said Senior Services did reach out to the lab director of EORH to provide COVID testing at the senior centers and to the staff, but was told they couldn't do it. Mr. Dutton said there is misinformation out there and we are trying to clarify that. They have talked to a lot of the seniors and they seem to understand what the county is trying to do and wants to continue to do to benefit them. Mr. Dutton said a levy renewal is coming up that does a lot of great work for seniors. Countless meals a day are provided and they are providing medical transportation to places like EORH for routine care and that only happens with a levy supported by the residents of Belmont County. "We're really proud of the program and will continue working with all partners, there is no exclusive arrangement here," said Mr. Dutton. Mayor Davies said there is money changing hands from Medicare and Medicaid so it is a financial gain for one. He said the newspaper article only mentioned WVU. Mr. Meyer said we have made it very clear it is not exclusive with WVU which we have said from the beginning.
