Mr. Dutton said the 2018 well explosion near Powhatan Point was a pretty sizable incident and Belmont County as a whole had very good reaction from a disaster services standpoint. He noted the county added backup power since last year's heavy winter storms.

Jeff Felton, Job and Family Services Director, explained changes that will be occurring with benefits due to the ending of the pandemic classification. The food assistance recipients should receive their last supplement yesterday. Medicaid cases are reviewed to determine eligibility once a year from date applied.
