Mr. Dutton said the board has been having conversations for some time regarding a new shelter. This will give them a rough estimate of what a new building will cost to see if even possible. The current shelter can not be modified.

OPEN PUBLIC FORUM-Several Animal Shelter volunteers, former staff and others voiced their concerns over the Animal Shelter Volunteer Program being suspended. Aaron Apitzsch and his wife Jodi have been volunteering for 19 years. He said they do not feel Belmont County's program is run efficiently and suggested looking at how surrounding counties handle theirs. He said they are only trying to help and are not able to. Mr. Dutton said the program is just suspended, not cancelled. The board is in the process of gathering information before they make a decision. He said they appreciate the work of the volunteers, but the shelter has to be able to run without volunteers if needed. Kathy Skatula, former shelter employee, feels there is a lot of turnover at the shelter. Mr. Dutton said they see a lot of turnover across the county, a pay increase was done to try to help with the issue. Ms. Skatula also feels management is not training the staff properly. Others voiced their concerns about dogs being euthanized that should not be. Several individuals spoke on the importance of having a volunteer program at the shelter.
