OPEN PUBLIC FORUM-Frank Papini, St. Clairsville, inquired about the status of the Volunteer Program at the Animal Shelter. Mr. Dutton said it will be resuming soon with some changes. Jodi Apitzsch, St. Clairsville, asked about the certified letter her and her husband received stating they could no longer volunteer at the shelter. She doesn't think the reasons listed are accurate and wanted to know who provided that information. Mr. Dutton said, "I don't know that we agree it's not accurate, I don't know this is the forum to discuss this. It is a volunteer program; we have the ability to make determination on volunteers that are participating at the shelter. We have made that determination and beyond that I don't know that there is any more of a comment from our board." He added four years ago there was discussion regarding an alleged incident with the Apitzsch's and they moved forward. Mr. Dutton said information is received from staff at the Animal Shelter and they utilize that information the best that they can.

Joyce Hartley, Shadyside, voiced her concern regarding a ditch issue near her property. She said water is running onto her property and is causing damage to her home. Ms. Hartley added she confirmed it belongs to the county and she wants something done by the County Engineer. She said the county is in violation of ORC 5589.03, 5589.06 and 5589.22. and there should have been a contract for the road work. Ms. Hartley said she purchased the property through Sulek & Dutton. She played a recording on her phone and then left the meeting. Mr. Dutton said, for the record, Ms. Hartley has been told on multiple occasions that the road work that was done has nothing to do with the Belmont County Commissioners' office. He said she has been told before that the Belmont County Engineer is a separate elected official with separate budget and responsibilities and if she has any questions for the County Engineer she needs to direct those questions to him. She has also been told on multiple occasions by the Mead Township Trustees this is a township issue and not a county issue. She has approached the Mead Township Trustees on multiple occasions, to the point where she had to be removed from the meeting due to her conduct at the meeting. Mr. Dutton said from his understanding, they have tried to work with her as much as possible, to no avail. Mr. Dutton added his family has no business interest or has ever had any business interest in Sulek & Dutton, his brother was a realtor there 15 years ago, but has not been a realtor there for over 10 years. Mr. Dutton said he did not know what the recording was that Ms. Hartley played.
