IN THE MATTER OF APPROVING THE MEMORANDUM OF UNDERSTANDING
BETWEEN THE BOARD OF COMMISSIONERS AND CANDACE FLEAGANE
Motion made by Mr. Meyer, seconded by Mr. Dutton to approve and authorize Commission President J. P. Dutton to sign the Memorandum of Understanding, effective January 1, 2024 through December 31, 2024, by and between the Board of County Commissioners of Belmont County, Ohio and Candace Fleagane; Ms. Fleagane will assist County with providing for the care and control of cats by reimbursing the County for various expenses associated with the care and control of cats.

This Memorandum of Understanding is entered into this <u>29th</u> day of <u>November</u>, 2023, by and between the Board of County Commissioners of Belmont County, Ohio ("County") and Candace Fleagane ("Fleagane").

WHEREAS, County operates an Animal Shelter primarily for the care and control of dogs pursuant to the Ohio Revised Code; and WHEREAS, Fleagane is concerned with the care and control of cats and desires to assist County with providing for the care and control of cats by reimbursing the County for various expenses associated with the care and control of cats. NOW THEREFORE, County and Fleagane agree as follows:

- (1) During the term of this agreement, County shall provide a room at the Animal Shelter to house cats that have been surrendered to the Shelter until such time as said cats may be adopted. It is anticipated that the room can accommodate up to 32 cats at any one time.
- Fleagane agrees to assume the cost of providing initial care of cats surrendered to the Shelter so that the same may be adopted. These initial costs shall include routine spay and neutering, and any general health issues. Fleagane shall not assume the cost associated with treatment of any extraordinary injury or serious disease of any individual cat unless agreed to by Fleagane prior to treatment
- (3) County shall provide spay and neutering services and initial care of the cats through the services of local veterinarians.
- Within ten (10) days of the end of each calendar month, County shall submit to Fleagane the costs incurred by County for spaying, neutering, and providing general routine healthcare to the cats during the preceding calendar month and Fleagane shall pay said amount in full to County within 30 days of receiving the invoice for said costs.
- (5) Since Fleagane is subsidizing the cost of initial healthcare for the cats, the County agrees to reduce the adoption fee for said cats to \$50.00 to allow for more adoptions.
- (6) This Agreement may be terminated by either party upon ten (10) days' notice to the other in writing.
- (7) This Memorandum of Understanding shall remain in effect through, and including, December 31, 2024 and shall terminate at that time unless renewed in writing by County and Fleagane.

Mr. Dutton said this is the 6th or 7th year for this MOU. Ms. Fleagane has a non-profit organization, Cat Stray Shun, that has been involved in Belmont County Animal Shelter. There is a cat room at the Belmont County Animal Shelter, the population is usually around 30-35 cats. All of the expenses for the care of cats is covered by Cat Stray Shun. Mr. Dutton said by Ohio Revised Code counties are only required to be responsible for dogs, a lot of that is due to public safety. He added they had a meeting before this agreement was in place and met with all of the non-profits in Belmont County trying to find ways to work together and Cat Stray Shun was willing to take this project on.

2024 LEASE AGREEMENT

The Board of County Commissioners of Belmont County, Ohio the Lessor, in consideration of the rents and covenants stipulated to be paid and performed by the **Belmont County Department of Job & Family Services**, Lessee, leases to the Lessee, the following premises:

Fourteen thousand two hundred twenty five (14,225) square feet of office space in the building known as the **310 Fox Shannon Place** and located at **310 Fox Shannon Place**, **St. Clairsville**, Ohio 43950.

For the term of one (1) year commencing on January 1, 2024 at a total cost of \$1,421.21, payable in elven (11) monthly installments of \$118.43 and one (1) monthly installment of \$118.48 on the first day of each month, in advance, all rent being payable at the office of the Lessor, Belmont County Courthouse, St. Clairsville, Ohio. Said amount is calculated from the original amortization schedule. The Lessor and Lessee agree as follows:

- 1. That the Lessee will pay the rent at the time and place and in the manner specified above;
- 2. That the Lessee will occupy the premises in a safe and proper manner;
- 3. That the Lessee will not assign this lease, nor sublet the premises, without the written consent of Lessor;
- 4. That the Lessee will make no alterations or additions in the premises without the written consent of Lessor;
- 5. That the Lessee will permit the Lessor, or agents of the Lessor, to enter upon the premises, at all reasonable times, to examine the condition of the premises and to make repairs;
- 6. That the Lessee will surrender and deliver up the premises at the end of the term, in as good order and condition as the premises are at the time of occupancy, reasonable use or natural wear and tear and damage by fire or unavoidable casualty, expected;
- 7. That any failure of the Lessor to enforce rights or seek remedies upon any default of the Lessee with respect to the obligations of the Lessee shall not prejudice or affect rights or remedies of the Lessor in the event of any subsequent default of the Lessee.
- 8. Lessor shall be held harmless by Lessee from any liabilities for damages to any person or any property in or upon the premises and the adjoining side walk and parking spaces allocated to use of Lessee, including the person and property of Lessee, and its employees and all persons in the building at its or their invitation. All property kept, stored and maintained in the premises shall be so kept, stored or maintained at the risk of Lessee. Lessee shall not suffer or give cause for the filing of any liens against the premises.
- 9. Lessee shall provide its own telephone connections and services upon the approval of Lessor.
- 10. Lessee agrees to pay rent for capital cost purposes at the amounts designated in the forty (40) year amortization schedule on file with the Commissioners' office. Property insurance on this facility is collected in the annual cost allocation plan as part of the Shared indirect cost amount. Other operating costs such as utilities, etc., are paid directly by Lessee.
- 11. This agreement may be terminated by either party with a sixty (60) day written notice by certified registered mail.
- 12. The Lessee shall be responsible for maintenance service repairs and janitorial service.
- 13. Lessor shall supply adequate parking spaces for use by Lessee's employees and customers.
- 14. If the Lessee breaches any of its agreements, or vacates the premises during the term for the highest obtainable rent and may recover from the Lessee any deficiency between the amount obtained and the rent reserved.
- 15. If the premises, without any fault of the Lessee, are made unfit for occupancy by the elements, or other cause, the Lessee may surrender possession of the premises to the Lessor and terminate the lease.
- 16. All rights and remedies under this lease shall be cumulative and not exclusive of any rights and remedies available at law or in equity.
- 17. This lease and all its terms shall inure to the benefit of and be binding upon the legal successors in interest of Lessor and Lessee.

Frank Shaffer, Pultney Township Trustee, commended the Commissioners on taking care of county buildings. Mr. Dutton said they have gotten behind, as a county, in terms of facilities and are now playing catch up. They are making a lot of progress. He said three buildings needed to be demolished. The former Hab Center was demolished earlier in the year at no expense to Belmont County. The second building being worked on now is the former County Home. The third building houses Belmont County Records, but as soon as the project is completed to move the records to another facility that building will be demolished. Mr. Dutton said two buildings were auctioned off in October that the county had no use for and didn't want to have the upkeep. He noted they are hoping to secure some funding through the Land Bank to do some of the remediation work at the former jail.

OPEN PUBLIC FORUM-Sandy Lewis, Shadyside, said she is happy to see everyone working together to get the dogs adopted. She asked if the dogs left outside have straw when the weather is cold. Mr. Dutton said all of the dogs are kept in the shelter overnight. They may go outside some through the day. Mr. Meyer said he is thankful the adoptions are going on. He said over the last few weeks the shelter has taken a very bad rap in a lot of instances. A lot of things said have been unfounded or untrue about the dog warden and the staff. They are very diligent about doing their job. Mr. Meyer said they are not cruel to the animals and there is no death list. He said they have looked into the allegations. Mr. Meyer said the Commissioners have a lot of other things going on in the county. They have talked to other elected officials about the accusations and they are unfounded. Mr. Meyer said there were a few euthanizations, there are 100's of dogs that go through the shelter every year that are either reclaimed by their owners, adopted out or go to other non-profits to try to get them adopted out. He said the staff goes above and beyond what they need to do to care for the animals. Some things have been said on Facebook about the dog warden and staff that was uncalled for. Saying the dogs were not marketed was false. Mr. Meyer said the euthanizations are done professionally by a veterinarian and they are not taken lightly. He said when the staff feels unsafe it's a problem. Mr. Meyer said he appreciates all of the donations to the shelter. They have taken multiple hours out of the regular meetings to discuss, but also had a 2 ½ hour evening meeting. He doesn't have a problem if someone disagrees with them, but there is a way to address it. Mr. Meyer said they support the shelter staff 100% and they are not getting fired unless they do something that is against the law. Vince Lewis asked if the volunteer program is back on track. Mr. Meyer said there are people that apply to just go out and nib so they have to cipher through the applications because people are not going out for the right intentions. Mr. Dutton said the volunteer program was paused in early June for a small period of time. Since then there have been volunteers. The volunteers are there to assist the staff towards the goals of the organizations. When that gets deviated from it becomes a function of whether or not that volunteer is still helpful to the organization. He added they are volunteers, not an employee so they are under a different classification.
