## Dave Jones, Fair Board member, re: Update on new building:

Mr. Jones said the building is about 40% completed. All of the utilities are in and improved. The contractor is installing ductwork for heating and air conditioning which is a slow process. He noted the cost of the new building is approximately \$1 million. The Belmont County

Commissioners contributed some funding and approximately \$400,000 in federal funding was secured by Ohio Representative Don Jones. Mr. Jones said the new building will house Soil & Water and OSU Extension. When they move in someone will be at the site daily through the week. Mr. Dutton thanked Representative Jones for his help in securing the federal funding. He added the Belmont County Fairgrounds is the fastest growing, nicest facility in our part of the state. Mr. Jones said the fairgrounds sits on 150 acres, it's a large very modern complex.

**OPEN PUBLIC FORUM-**Frank Shaffer, Pultney Township Trustee, commended the Commissioners on moving people out of old buildings and into new ones. Mr. Dutton said they are well on their way for the Health Department, Coroner's office and Records Building. Once that project is completed there will be twelve different county entities in the last six years that have had their space either modernized or upgraded. Some of those spaces were in poor condition. Mr. Dutton said Belmont County is in a good spot financially. They are chipping away at tens of millions of dollars on projects that need to happen at some point, whether it's facilities or infrastructure.

Mr. Dutton said there are hundreds of thousands of dollars of improvements that need to be done at Sargus over time. State Representative Don Jones secured \$500,000 towards the Sargus Detention Center. They are now working with the new state senator on the senate side for possibly an additional \$500,000 to come to the county for more renovation work needed at Sargus. He noted it is a joint district with Harrison County. Monroe County and Guernsey County both utilize the facility.
