These projects take a lot of time. Some residents have wells, but they are contaminated due to past mining practices so they are hauling water.

#### John Rowan, Executive Director and Crystal Smith, Office Manager of Oakview Juvenile Residential Center **Re: Expansion of Program**

Mr. Rowan said Oakview opened in 1994 and is funded by the Ohio Department of Youth Services. He said they were the only juvenile facility in Ohio that was awarded an expansion in 2024. Currently Oakview can house 16 youth, but will be expanding to house 24 youth. More staff will need to be hired. Oakview serves males ages 12-18. They can take youth from any county in Ohio. The average length of the program is six months. Mr. Rowan said they work to get the youth transitioned back into the community. They try to make the youth better citizens and an asset to the community. The youth attend school on site and receive mental health treatment and drug and alcohol treatment if needed and participate in family counseling.
