SSOBC is continuing to provide about 1,200 meals daily and 25-35 seniors are transported daily for medical appointments. The attendance at senior centers is back up to pre-COVID levels. "Seniors will either need an app on their phone or wait four to six weeks for their voucher to come in the form of a card this year.
