Discussion re: new building project- Mr. Dutton said, "This is an extremely expensive project. This is roughly a \$20 million project. I think it's the second most expensive project we have ever taken on, number one being our current water plant, which was built a couple years ago for \$28 million. We're solving a lot of issues with this project. We're solving space issues with the Health Department, an important situation in terms of Belmont County Records, in terms of where they're going to be located, along with demolishing that building once the records are out of the current space. And then, of course, we've never had space for the Belmont County Coroner." Coroner Dr. Amanda Fisher said, "A lot of people don't realize and are kind of shocked to find out that, first of all, we don't have a physical office at all. So everything is done at my private practice: meeting families, giving loved ones belongings. Everything has to go through my office." Dr. Fisher added the current morgue is a shed in a parking lot of the Health Department. Mr. Dutton noted the project will be paid for with some Federal dollars, but it will be more than that. He said the project should be completed sometime next year.

## **Belmont County Budget Hearing FY 2026**

Mr. Dutton said this is the start of the budget season. Information is collected from each department. This information is very rough and will change. A meeting will be held with the County Auditor next month to see where the projections are. The amounts turned in from the departments are "asks" and is usually above the top line number so cuts will have to be made. Mr. Dutton said the potential IRS penalty could also pose a problem and potentially put us in a pinch.
