BELMONT COUNTY DEPARTMENT OF JOB AND FAMILY SERVICES

PURCHASE OF SERVICE CONTRACT

This agreement to utilize Workforce Investment Act (WIA) funds and other funding sources to support the services of a local coordinator at Belmont Technical College is made and entered into June 4, 2001 by and between the Belmont County Department of Job and Family Services (hereinafter referred to as Department) and Belmont Technical College (hereinafter referred to as Provider). This agreement will be effective from July 1, 2001 through June 30, 2002 inclusive, unless otherwise terminated.

The purpose of this agreement is to fund a coordinator at Belmont Technical College to assist WIA participants in obtaining the necessary services they need to successfully complete their training program and to facilitate the coordination of WIA activities between the Department and Provider. The attached narrative outlines the responsibilities of the coordinator under this agreement.

General Provisions

A. Provider agrees that the use or disclosure of any information concerning qualified customers for any purpose not related to the delivery of the purchased services is prohibited except upon written consent of the customer.

B. The Provider understands that this written agreement superceded all oral agreements.

C. The Provider agrees that in the performance of this agreement there shall be no discrimination against any customer because of race, color, sex, religion, national origin, or handicapped conditions as specified in the Civil Rights Act of 1964 and the Rehabilitation Act of 1973 and all subsequent amendments. It is further agreed discrimination and the right to a method of appeal will be made available to all persons served under this agreement,

D. In the event the Provider receives an overpayment, Provider agrees to repay the Belmont County Department of Job and Family Services the amount to which the Provider is not entitled.

E. In the event that state and/or federal funding is no longer available to the Department, therefore requiring changes or termination will be effective on the date that the state and/or federal funding is no longer available, or, later as otherwise stipulated by the Department.

F. This agreement may be terminated by the Provider or the Department upon thirty days written notice. Failure to honor terms of this agreement and/or related state, federal, or local regulations shall result in the immediate termination of this agreement. If any of the terms of this agreement change, the Provider must notify the Department immediately.

G. This agreement may be terminated by means of a written instrument executed by all parties hereto. Payment Procedures

A. The maximum amount billable by the Provider to the Department is \$20,116.72 as specified in the attached budget unless otherwise modified by a written agreement.

B. The Provider understands that payment for all services provided in accordance with the provisions of this agreement depends on the availability of state and/or federal funds.

C. The Provider agrees to submit an invoice to the Department on a monthly basis. The Department agrees to review the invoice and provide reimbursement for services within thirty days of the receipt of the invoice or as soon as the County Auditor processes the payment.

D. Provider warrants the claims made to the Department for payment of services shall be for actual services rendered to eligible customers and do not duplicate claims made by the Provider to other sources of funds for the same service.

E. Payments made under this agreement will be allocated based on the percentage of WIA participants in each program title attending Belmont Technical College.

<u>Narrative</u>

Responsibilities of Coordinator

- 1. Provide cost of attendance information to Belmont WIA on a quarterly basis.
- 2. Provide copies of Financial Aid award letters for each client to WIA.

3. Gather and spend copies of BTC course placement test scores (ASSET or COMPASS) to WIA.

4. Report client withdrawals and non-attendance to WIA.

5. Send grade transcripts to WIA for each client, each quarter.

6. Track any/all clients who earn grades of "I" (Incomplete) and report all grade changes to WIA by transcript.

7. Insure that all clients obtain proper signatures on cost of attendance agreements.

8. Insure that all clients complete attendance forms in entirety to include student and faculty signatures.

Insure that all client mileage mileage reimbursements checks are accurate, if questioned.
 Complete educational information sharing forms.

11. Insure that all client transactions at bookstore are non-taxable.

12. Provide individual orientation for each new client, to include teaching clients how to read BTC class admittance permits.

13. Orient all new clients to BTC classroom building, to include showing them where their classes will meet by room.

14. Assist clients in registering their vehicles with the college.

15. Serve as intermediary between client and the agency by insuring the clients are made aware of when the agency needs to speak with them.

16. Attend group meetings of disclosed and newly unemployed workers to explain WIA function at Belmont Technical College.

17. Insure that WIA agencies are provided with current catalogs and course information.

18. Other related tasks as needed.

One goal of the Coordinator is to provide direct, personalized service to each client who enrolls at Belmont Technical College. The direct services provided by the Coordinator are performed in such a manner as to maximize the possibilities of client success while enrolled at Belmont Technical College.

Concurrent with the client service goal is the goal of providing quality, comprehensive services to the agency. This is accomplished through the high degree of personal contact with the clients which enables the Coordinator to report the status of clients to the agency in a timely, accurate basis. In turn the WIA staff never needs to search for the "right" BTC employee to contact with questions. The Coordinator provides a centralized point of information about the College and its various functions for the agency.

AND JUVENILE COURT/OAKVIEW JUVENILE REHAB GROUP HOME

Motion made by Mr. Thomas, seconded by Mr. Olexo to enter into the following agreement with the Ohio Department of Youth Services for the Oakview Juvenile Rehabilitation Facility Group Home.

> OHIO DEPARTMENT OF YOUTH SERVICES GRANT AGREEMENT FOR COMMUNITY CORRECTIONS FACILITIES

This Grant Agreement and Funding Application is made and entered into by and between the State of Ohio, Department of Youth Services (herein referred to as "Department"), and the Oakview Group Home (hereinafter referred to as "Grantee" as defined in Ohio Administrative Code 5139-61-02(H)), located in St. Clairsville, Ohio 43950.

The Grantee has made application to the Department for funds made available for operations and maintenance of the Facility, and has submitted a grant plan for the use of these funds. The Department approves funding for the Grantee in the sum of \$600,083 for the period beginning July 1, 2001, and ending June 30, 2002, subject to the terms and conditions of this agreement.

A. TERMS AND CONDITIONS

<u>Eligibility</u>

1. The Grantee agrees to implement the plan as outlined in the grant application submitted by the Grantee and approved by the Department (including any conditions hereafter imposed by the Department for purposes of provisional approval), which is attached hereto as Appendix A, and incorporated herein by reference.

2. The Grantee agrees to comply with Ohio Administrative Code Chapter 5139-61, "Community Juvenile Corrections Facilities Program Rules and Procedures" and 5139-63, "Community Juvenile Corrections Facilities Rules and Procedures"; and Ohio Revised Code Section 5139.36, and other related sections.

3. The obligations of the Department under this agreement are subject to the determination of the Director that sufficient funds have been appropriated by the General Assembly to the Department for the purposes of this agreement and to the certification of the availability of such funds by the Director of Budget and Management as required by R.C. 126.07.

4. The initial amount of funding approved by the Department under this agreement is subject to quarterly review by the Department and may be increased or reduced based upon operational and maintenance needs of the Facility and availability of funds. Budget adjustments will not be made without this review. The Facility will be notified in writing of any change in the initial funding within 10 working days after the review of the budget. The decision of the Director shall be final and is not appealable.

5. The Grantee agrees to indemnify and hold harmless the Department from any claims and for any liability resulting from the failure by the Grantee to perform the duties required by this Agreement or applicable law.

6. The Grantee agrees that it will not employ as staff, or on a contract basis, any employee of the Department.

7. The Grantee will make its best efforts to augment the funding received from the Department through other funding resources, including but not limited to: tuition reimbursement, Medicaid, NSLA, and other sources identified by the Department.

8. The Grantee agrees that the only youth admitted and served by the Facility shall be those who would have otherwise been committed to the Department.

9. The Grantee agrees that the approved funds shall only be used to support operations and maintenance costs of the Facility and shall not be used for the provision of aftercare services.

B. <u>Program Evaluation:</u>

1) The Grantee shall maintain statistical records for the grant in the format and frequency as established by the Department.

2) The Grantee shall prepare and submit to the Department a report comprised of statistical data pursuant to the Department's instructions.

3) The Grantee shall prepare and submit to the Department reports comprised of the statistical data set forth above based upon the time frame established by the Department.

4) The Grantee agrees to maintain intake and assessment forms for each youth referred or placed in the Facility.

5) The Grantee acknowledges that failure to comply with Items (B)(1) through (4) of this Grant Agreement may result in delayed grant payments to the Grantee.

C. <u>Compliance</u>

1. The Grantee agrees that it will cooperate with and provide any additional information as may be required by the Department to fulfill its obligations in the administration and evaluation of the community-based corrections facility and program.

2. The Grantee understands that failure to comply with the rules of Chapter 5139.61 and 5139.63 of the Ohio Administrative Code, which are applicable under this Grant Agreement, may be cause for the Director of the Department of Youth Services to terminate further funding. Furthermore, the Grant Agreement may be terminated by the Department if:

A. There has been a reduction in the quality and extent of the program services.

B. There has been a financial or audit disclosure involving misuse of state funds.

C. A substantial reduction in commitments to the Department is not achieved, as indicated in the approved plan.

D. Program modifications required by the Department are not made.

3. The Grantee agrees to compensate the Department for the costs of any audit performed by the Auditor of State which is deemed necessary by the Department.

D. <u>Termination</u>

1. The Department shall provide written notice to the Grantee of any intention to terminate funding. This notice will be provided thirty (30) days prior to any such action being taken.

2. The Grantee shall have thirty (30) days following the receipt of such notice to present a request for reconsideration to the Director of the Department of Youth Services. The decision of the Director shall be final and is not appealable.

3. Either the Department or the Grantee may terminate this agreement without cause, by providing the other party written notification of the date of the termination, which shall not be less than thirty (30) days from the date of the written notice.
