Commissioner Olexo attempted to clarify the monies to be borrowed. "The last monies borrowed were done so at 3.19%. We're hoping for that low of a rate again. This is the first, we hope, in a continued series of projects that we previously announced." Commissioner Thomas stated, "This money will fund the first two projects announced, Lashley Road/ Hawthorne Hill; and Route 9 Booster Station. This booster station will allow us to extend the water service to those directly south in the county. This will permit us to provide adequate service, in terms of pressure, in the future. Additional projects will be bid later this year or early in 2002. Those projects will include Barnesville, and Jeremy Midei, Reporter, The Times Leader, asked if the one million Lamira/Loomis." dollars was just for these two projects. Commissioner Olexo stated, "We are starting with these two first. We are not ready to bid the others until the new year. We won't borrow the money for them until they are ready to be let out for bid. Our intent is to follow through with our plan. These two are just the first in a series. It is going to be January before it is ready to be let out." Commissioner Thomas stated they would be let out for bid no later than Summer 2002.

Commissioner Olexo stated, "Four administrative nurses will receive a 2% pay increase retroactive to January 2000." The reason for this is the nurses received a 2% pay raise at that time, rather than a 4% increase which is the norm for all county employees. Commissioner Olexo stated this is an effort to make raises uniform throughout the county. He continued stating there are currently 110 employees at Park Health Center, however, this number fluctuates greatly, and "This is one way to try to keep quality employees." Commissioner Thomas amended the motion for raises to exclude the Park Health Administrator and the Director of Nursing. He explained, "These two employees are fairly new and we have previously addressed their pay rates."

RE: UPDATE BY BUILDING AND GROUNDS SUPERINTENDENT

William Eddy, Building and Grounds Superintendent, came before the Board with updates on various issues pending. Mr. Eddy stated, "There is no new information pertaining to the Bethesda Satellite building boiler. I have talked with William Hooker, Architect, and he is ok with us designing our own. I am currently gathering prices." Also pertaining to the Bethesda Building, Mr. Eddy stated, "Mr. Pat Swallie wants to rent more space at the Bethesda Building." When questioned by Commissioner Thomas as to any renovations that might be required for this additional space, Mr. Eddy assured the Board that Mr. Swallie would make any needed changes with his own money and labor. Mr. Eddy informed the Board that he feels this is a positive thing for the county.

In matter regarding the Martins Ferry Satellite Building, Mr. Eddy informed the board he has discussed the issue of a compressor for the air conditioning system with three or four vendors, and feels it will have to be replaced.

Concerning the County Auction, tentatively scheduled for October 20, 2001, Mr. Eddy asked for permission to proceed. He recommended acquiring the services of auctioneer David Jones, who had serviced the past two years in a very professional manner. Commissioner Thomas asked, "We need to check the journal and see the prior Boards of Commissioners wording on this issue. We need to spread it around, and not go with just one auctioneer, if we do not have to have bids for the job. In looking in the phone book, I notice four names of auctioneers in the county. Mr. Eddy stated that the county, "really relies on the auctioneer's for keeping items clear and orderly. Dave Jones did an excellent job." Darlene Pempek, Clerk, Belmont County Commissioners, stated that the proceeds from the auction would be returned to the various agencies, which are involved.
