OPEN PUBLIC FORUM - Richard Hord referred to a local newspaper column wherein Dwayne Pielech's letter of resignation was the subject. Mr. Hord was concerned about a section wherein Mr. Pielech stated, "There are more and more important Agency decisions accumulating at the Courthouse in which the Board hasn't completed. PUBLIC HEARING TESTIMONY ADDITIONAL PERMISSIVE VEHICLE LICENSE FEE

The purpose of this report is to explain to the Belmont County Commissioners why they should enact the Local Permissive Vehicle License Fee in accordance with Section 4504.15 and 4504.16 of the Ohio Revised Code. By doing so, this will increase the annual renewal fee for vehicle licenses by ten dollars (\$10.00).

Because of my previous request that this be enacted, you are holding this public hearing today. I would like to explain why I made this request.

Belmont County has 308 miles of County Highway to maintain, along with 280 bridges located on these County Highways and Township Roads. This requires employees, equipment and materials to pave, patch, stripe, mow, berm ditch, provide snow and ice control, to install culvert, build and repair bridges, install guardrail and all the other work necessary to make our roads and bridges safe for the traveling public. All of this requires money.

The funds to do the above-mentioned work come from several sources and are placed in the Motor Vehicle Gasoline Tax (MVGT) account. The funds are from the gasoline tax, license plate fees, fines, interest and refunds. Due to the economy, our income in 2012 was \$181,500 less than that received in 2007 (see attachment A). We also receive some outside funds from the Federal Highway Administration (FHWA) and Ohio Public Works Commission (OPWC).

Our cost of doing business has risen steadily the past decade. An example is the cost of paving one (1) mile of highway, 20' wide has risen from \$29,500 in 2003 to \$65,400 in 2012 (see attachment B). According to trade publication Engineering News Record, the construction cost index has risen close to 30% during that period of time.

Our roads need resurfaced. The last paving of any County Highway was during 2012 when 1.5 mile of County Highway 4 (Willow Grove Road) was resurfaced, with 100% being paid by a local Coal Company. Before that was in 2010 when Federal Funds were received to pave County Highway 28A and 28B (Mall and Banfield Roads) and OPWC funds were used to pave County Highway 56 (Cats Run Road). 2008 was the last time 100% County funds were used to pave any County Highway. At that time, portions of County Highway 30 (Dixon Hill Road) and County Highway 214 (Bellaire-High Ridge Road) were resurfaced, totaling only 2.48 miles. Before that, we were paving 5 to 10 miles each year (see attachment C).

We still have a bridge problem. Although we have replaced 10-15 bridges per year over the last decade, we still have 80 bridges which cannot carry legal loads, and are posted with load limits between 32 tons and 4 tons. About half of these bridges cannot carry school buses, emergency vehicles, fuel trucks, etc. (see attachment D & E). We are able to replace small bridges, 10'-50' spans with our employees, but larger bridges must be replaced by private contractors, most are which funded by OPWC or FHWA. Which costs between \$500,000 - \$1,200,000. These bridges require a local match of 20% to 26% of the contract costs.

What have we done to help reduce our costs? In 2007, our department had 50 employees, today only 40. We have cut back on the purchase of new vehicles and equipment. We have 25 dump trucks with more than half of these purchased prior to 2000. Only 8 of these trucks have less than 100,000 miles on them. Most of our work trucks and pickup trucks have in excess of 100,000 miles. About half of our heavy equipment was purchased prior to 2000 (see attachment F).

It has been estimated by the Bureau of Motor Vehicles (BMV) that, based on 2011 registration, we will receive \$536,006 (see attachment G) by enacting this increased fee. Also, our 16 townships will receive \$141,384 and 12 of our 14 municipalities will receive \$59,910 (see attachment H). Due to part year registrations they recommend for budget purposes we use 85% of the amount.

Therefore, in closing, I ask that you vote to enact provisions in Ohio Revised Code 4504.15 and 4504.16. This will not solve all of our problems but will be of great benefit to have safer County Highways and Bridges, Township Roads and Municipal Streets.

Each registration will only cost only an additional 83 cents per month, which is less than 3 cents per day.

Thank you for your consideration of this matter.

DISCUSSION HELD - First to speak was Pease Township Trustee Mike Bianconi. He advised he was speaking on behalf of the Belmont County Township Trustees Association. He stated he is for enacting this tax. He noted it will not solve all the problems, but will certainly help. He said at the recent Township Association meeting, it was voted to support this tax. Frank Papini of Bridgeport said he knows we do have a problem as far as money goes. He does not totally agree with the \$10.00 increase because too many people are on fixed incomes. He stated he doesn't think enough is being done as far as generating county revenues. It appears to him the governor is sitting on a \$2 billion rainy day fund and there aren't any efforts being made to try to tap into that. He said he thinks we are coddling the oil and gas industry. He wants demands put on them for them to pay their fair share. He said it is their trucks that are tearing up our roads more than anyone else. Ed Hood of Shadyside said he agrees with Mr. Bennett needing money. He noted Social Security is getting tighter all the time and at the end of December he will lose his health insurance from Consol Energy. They are dropping retirees. He has seen his property taxes go up \$108.00 each half, with no improvements made. His car, homeowner and utilities have increased. He stated the lottery was to be for highways and education. All schools are looking for levies. He is digging into his savings now to pay monthly bills. Mike Klinec stated he is opposed for personal reasons. St. Clairsville businessman John Swan stated he is opposed to the tax. He also noted the large population of senior citizens in the county and their retirements and benefits being cut. All the schools and parks are hurting for money. He also said the average person in Belmont County probably has 2 to 3 cars. Businesses have several vehicles. He felt there should be other ways to do this. St. Clairsville Mayor Bob Vincenzo was present, but informed that he was speaking as a resident and not on behalf of the city. He remarked that he knows there are senior citizens to consider and all the problems addressed by Mr. Hood, however, we all travel county roads. He noted that one incident on a bad county road that requires a repair at a garage would be significantly higher than the \$10.00 tax. He said all the county roads are really, really bad. He supports the tax as he sees no other solution. He also agrees the oil and gas issue needs explored, but Mr. Bennett already has RUMA's in place. He supports this as an individual. Pultney Township Trustee Frank Shaffer advised he is in favor of the \$10.00 tax. He feels it is the cheapest way to go. He knows it won't be a cure all. It is a safety factor. He feels \$10.00 is not to much to pay to save a life. He said a levy would never pass. John Swan said he agreed in a way, but not everyone has \$10.00 in their pocket. Mr. Swan said we have a CAT tax in the State of Ohio. It is for business to participate in the state to sell their products. He suggested a BAT tax (Business Activity Tax); surmising if we had that and put an assessment on of \$5.00 per business, it might give us some assistance. Then you are not taking it from those that can't afford it. Mr. Hood asked where the money goes from the four (4) casinos that are now in the State of Ohio. Mr. Coffland answered that each county receives a certain portion back. The host counties, he believes, receive a little more. Mr. Coffland gave approximate figures on Belmont County's portion as follows: 1st quarter - \$140,000. 2nd quarter was in the neighborhood of \$160,000. The first quarter money was used to pave and line the back courthouse parking lot and repair a wall that was collapsing. Some money was used to do upgrades at the courthouse. Mr. Coffland advised he is on the county roads all the time. He said in the western part of the county where there is oil activity, the Engineer and Deputy Engineer is working with those companies and getting some roads paved.
The Engineer's Dept. has been very aggressive in getting those roads taken care of with the RUMA's in place and working with the companies. Mr. Coffland stated we have a major problem with our bridges and if we don't do something with our roads soon, they will be back to gravel. He said we have close to 300 miles of paving that is not being done, but he doesn't know what the answer is. It is a problem everywhere. Mr. Coffland advised we listen to complaints every day in here about the potholes, the roads, the lines, the trees, the signage, and the lighting. We do not have the money right now to deal with it. If we had the money, Mr. Coffland is in favor of giving it to the Engineer. We have faced a lot of cuts and have not been able to fund the way it was in the past. He said when you put the weight limits down on the bridges so low, we can no longer put fire trucks across them. Mr. Coffland advised the Township Association agreed to turn over the Issue II project to the County Commissioners to apply every year for an Issue II project. This takes money out of each township, but allows the county to apply for up to \$390,000.00 in grants. Frank Papini asked why we can't access the rainy day fund. Mrs. Favede said she couldn't agree more. She said she thinks our greatest problem is just that. "The money that is missing from this county has not been lost; it has been taken from Belmont County and our municipalities and our townships by the state," said Mrs. Favede. She further noted, "To brag that we are sitting on a \$2 billion rainy day fund while our schools are struggling and our townships are shutting out their lights...." Her biggest fear is that we are becoming complacent and continue to allow that to take place and tax people more. She said we have to continue to demand that Local Government Funds be returned. The State of Ohio is financially stable at this point. Mrs. Favede stated that she testified before the Ways and Means Committee in regard to Local Government Funds and the necessity of it being returned. She said we want a portion of a severance tax to be returned to the host counties of oil and gas.

Richard Hord asked if this is a permanent license fee increase. Mr. Bennett responded that it was permanent. Mr. Hord noted the two public hearings were scheduled in the morning. He asked if the board might consider having one in the evening to accommodate those whose work schedules might conflict with that time. Mrs. Favede said he had a valid point, but we can't change the dates at this time since the process has been started. Mr. Hord asked if there were other options considered. Mr. Bennett said he thinks this is the only viable option. The only other option would be to put a property tax on, but he did not want to put this tax on a ballot and be up against the same time school levies are up, the senior levies, or any other levies. John White said he is retired, on a fixed income and against the tax. Mrs. Favede clarified the purpose of the hearing is to determine if we will vote for or against the tax.

Deputy County Engineer Mike Wahl said he wasn't planning on speaking this morning, but feels he has to. He said being a small county without much money there are only two engineers for the county. One of the hats he wears is the Belmont Co. Bridge Inspector. Many of the bridges are 4 - 10 tons. That is nowhere near the capacity for a fire truck or the large current rescue squads. For safety sake, he said we need to do something with these bridges and do it quickly. There are bridges with holes in the beams. He said we cannot replace these bridges fast enough. There is a dire need now for this money. He said he is asking that you look past the dollars per month and look at the safety of your loved ones.

Mr. Bennett concluded by stating he appreciated everyone coming in and expressing their opinions. He advised they replaced over 100 bridges in the last 10 years. Mrs. Favede concluded by announcing the next public hearing will be held on May 1 at 10:30 a.m.

11:00 Bryan Minder, Acting Director, Belmont County 911 Re: National County Government Month presentation

Bryan Minder began his presentation stating he started in 1997 when the 911 Center opened. He was employed as a dispatcher and has worked his way up to Acting Director as of this past December. They dispatch for 13 law enforcement agencies and 24 fire departments. Initially six (6) PSAPs where established. (Public Safety Answering Points) They were in Bellaire, Bridgeport, Barnesville, Shadyside, Martins Ferry and St. Clairsville. Today only 2 of those 6 remain as 24 hour PSAPs due to budget cuts within their villages or cities. Two are part-time, which is Barnesville and Bridgeport. Currently the staff consists of one director, an administrative assistant, a supervisor, 12 full-time dispatchers and six part-time dispatchers. Three dispatchers are on duty 24 hours a day, seven days a week. In addition to the law and fire departments that they dispatch for, they are also responsible for the dispatching accountability of probation, game warden, coroner, Dept. of Job & Family Services after hours for emergencies involving children and adults, and the county EMA. 911's role in the community is to provide a centralized answering service for emergencies for anyone in Belmont County with exception of Martins Ferry and St. Clairsville, who still have their own dispatching police departments. Their dispatchers are very professional and very well trained. They receive continuing education every two years and three types of call taking, which would be law, fire and medical. They also receive additional training in specialized things such as active shooter incidents and CPR. This department is also responsible for the rural house numbering of any structure outside of a city of village limit. 911 is a single, centralized center to answer emergency calls and to account for everyone who responds to those calls. It allows for better coordination and organization for large scale incidents, whether that be flooding, fire, severe weather, etc. The center gives them an overall consistent approach of how they answer calls, what information is gathered, and what information is given out to the first responders. A few recent additions to enhance the service to the residents of the county are the fire and law enforcement departments were provided, by funding from the Commissioners, with mapping software in their vehicles. It will allow them to see where they are going, before they leave. It is called MECCMap. This system will help reduce response time and help when mutual aid is needed. They have implemented CityWatch which is a Reverse 911 program. It allows 911 to call residents to notify them of safety issues and alerts. This system utilizes home phone numbers. If you would like to receive this service on your cell phone you can sign up on the 911 website, www.belmontcounty911.com and click on the link and your information can be put in their database. The 911 Center is in the beginning phases of a new radio system upgrade. It is a complete overhaul of the system that was put in place in 1997 and is being funded by a levy that was passes in November. The new system will give their first responders a more reliable and constant means of communication. In addition the to the levy, they have also been able to generate over \$2 million in grant funds over the last 3-4 years to help to replace some of this radio equipment. Future plans for 911, which is constantly changing with technology, will be the interoperable radio systems, which will allow communication across the State of Ohio and across state lines. Next will be the ability for people to contact 911 via text. It is not here today, but in the next year or two you will probably have the ability to do so. 70%-75% of the calls coming into Belmont Co. 911 are from cell phones, which presents a problem with locating callers. Mr. Minder stressed the importance that 911 is for emergency use only.
